2. Rules

- c) The dates for these competitions are published in the International Calendar of the FIS.
- d) The competition will follow the official program that will be available to all participants.
- e) JISAN Freestyle FIS World Cup 2006 finals will be followed by the winners award ceremony where national team members may be asked to participate
- f) The Organizing Committee has the right to change the competition schedule if necessary

5. Team Registration

Team registration will take place daily starting Sunday, February 26, 2006, from 9:00 AM to 10:00 PM at the competition office located in Jisan Forest Resort. http://fiswc.jisanresort.co.kr

All fees must be paid upon registration.

6. Accommodation

Accommodation for all teams and officials is provided at Jisan Condominium and Hotel Miranda in Icheon. All participants will get a voucher upon registration at the competition office.

Accommodation will be provided from Sunday, February 26 to Wednesday, March 1, 2006 (4 nights). Hotels are available on the first come first serve basis.

7. Meals

Breakfast and dinner will be provided at Jisan Condominium Cafeteria for all competitors, coaches and officials, commencing with dinner on Sunday, February 26 and concluding with breakfast on Thursday, March 2, 2006. One night including a breakfast and a dinner costs 45chf. Lunch is excluded from the service. Complete information will be provided upon check in at the competition office.

8. Ground transportation from Incheon Airport to Jisan Forest Resort

The OC will organize the transport for teams(athletes,coaches,etc.)in Korea(means from Incheon Airport to Jisan Forest Resort). Buses will be sent to the airport approximately 3 to 5 times per day for scheduled flights from each country.

9. Team Leader's Meeting

The First Team Leader's meeting will be held on Sunday, February 26, 2006 at 20.00.

10. Liability

All athletes, officials and other members of their National Association who attend and participate in the event shall do so at their own risk. In the case of accidents on courses during the event, Medical personnel from the Organizing Commettee and Ski Patrol Personnel will be responsible for any medical decision or evacuation to the local hospital in co-operation with the National Associations medical personnel on the entry form.

All competitors, coaches and officials will be informed on ski storage and wax room on the day of arrival at the competition office.
