EVENT OFFICE LOCATION – NEW!

The Maurice Young Millennium Place is the new home to the Nokia Snowboard FIS World Cup event office this year, and is located at 4335 Blackcomb Way, Whistler, BC VON 1B4. Millennium Place is located across from the BrewHouse Restaurant. Phone and fax numbers will follow closer to the event.

ACCOMMODATION / MEAL PROGRAM:

Available from December 4 – 12, 2005. Please complete the attached form for all athletes & officials who will utilize the accommodation/meal program and <u>return by October 19, 2005</u> via e-mail to <u>Lindsay@obrien.net</u> or fax to +1(604) 648-8699. The Organizing Committee will coordinate all bookings. Information must be received from the teams by the set deadline to guarantee availability and the FIS rate.

All accommodations are centrally located in the heart of Whistler Resort and within walking distance to the lifts. Teams will receive confirmation on their hotel reservation along with hotel name & location via e-mail or fax prior to arriving in Whistler. A listing of team hotel locations will also be posted at the Maurice Young Millennium Place for after-hours arrivals.

All teams will be_required to pay all accommodation and meal charges upon arrival. Team Captains check-in at the **Maurice Young Millennium Place**, Sunday, December 4 from 13:00 - 21:00. Follow the directional signs to the event office. Fees will be 50CHF (\$55 CAD plus 7% GST) per team member per day for accommodation, breakfast and dinner, (teams are required to make their own arrangements for lunch). GST is refundable for all non-Canadian residents. Refund forms will be available at the event office.

The packages cannot be broken up between meals and accommodations (unless written notification is provided by October 19) and all team captains will be charged for the full package of any athletes registered for the FIS accommodation and meal plan. All payments must be in CAD currency by money order, Visa, MasterCard or American Express.

TRANSPORTATION from Vancouver Airport to Whistler Resort:

All teams are responsible for their own transportation arrangements. Please allow 2 $\frac{1}{2}$ to 3 hours travel time from the Vancouver Airport to Whistler Resort.

• The Perimeter Bus Line offers transportation aboard their Whistler Express starting at 09:30am and ending at 23:30, daily. The approximate cost is \$65 plus tax/ per person. Please visit their web site www.perimeterbus.com for a complete schedule and group rates.

Rental vehicles are also available from the airport. We will be circulating details on the recommended rental car company closer to the event.
