1. ENTRIES

Entries will only be accepted from National Ski Associations in accordance with the FIS quotas and rules for Freestyle Continental Cups 2009/2010. (20 competitors per Nation - no gender regulation, host Nation Quota + 10 extra, Non European Countries (per nation) 8 ladies and 8 men).

Entries must be submitted to the Organizing Committee no later than: Wednesday, December 9th.
