FIS has established nation Quotas for World Cup. National Ski Teams can only enter World Cup Ski Competitors according to the Quota limitations. The Quotas can be downloaded <http://www.fis-ski.com/data/document/basic-and-additional-quotas-11121.pdf>

Competitors entered into FIS Freestyle Ski World Cups must have the minimum required FIS Freestyle Ski points in the respective valid FIS points list.

The minimum FIS point requirements for FIS Freestyle Moguls and Dual Mogul World Cup events are 50 and for Aerials 100 FIS points.

3. REGISTRATION:

Team registration will take place at Competition Headquarters, which will be located at The Lodges at Deer Valley in Snow Park Village, the base area of Deer Valley, (2900 Deer Valley Drive East). Team registration/lodging check-in will take place daily **beginning on Monday, January 30 from 12:00 p.m. – 8:00 p.m.**

All fees and deposits must be paid upon registration.

To be eligible for participation in the 2012 Freestyle FIS World Cup each competitor must be a citizen of a country from the National Ski Association, with a license and prove this with a valid passport.

4. ACCOMMODATIONS:

Accommodations for mogul and aerial athletes and officials are provided at various condominiums in the Snow Park Village, the base area of Deer Valley Resort. Condominiums will have fully equipped kitchens. Exact lodging assignments will be confirmed upon arrival and check-in locations are as follows:

As per the FIS Rule 4.1 regarding accommodations, food and transportation, the venue will collect 15-CHF per person with no meal plan.

Accommodations will be provided beginning the night of Monday, January 30, departing the morning of Sunday, February 5, 2012.

At the time of check-in, **a major credit card will be required** to cover all incidentals. Each team will be held responsible for any damage incurred during their stay. All lodging accommodations are non-smoking, NO EXCEPTION. The accommodations that teams will stay in are privately owned vacation homes. Athletes should be respectful of these properties. Please remove ski boots at the door. Occupancy is limited to one adult per pillow in designated sleeping areas. Gatherings of any nature that exceed the occupancy limitations are prohibited. NO PETS. Additional housekeeping fees may apply at the discretion of Deer Valley Resort.

Note: Lodging charges apply to all persons listed on the Team Selection Form as of Wednesday, January 25, 2012, regardless of whether they attend the event. Requests for lodging after this point will be at the discretion of the organizer and fees will be based on prevailing rates (typically well in excess of the FIS rate). Payment must be made at time of check-in via cash or credit card only.

5. TRANSPORTATION:

Teams will be responsible for their own transportation to and from Deer Valley Resort and the Salt Lake City International Airport.
