1. The cost of the event for non-USFT entries is \$175.00 this includes all lift services for the week, your event bib, lunch voucher for competition days. THERE WILL BE NO REFUNDS, EXCEPT FOR INJURY PRIOR TO ARRIVAL, FOR ENTRY FEES RECEIVED FOR THE US FREESTYLE CHAMPIONSHIPS. ALL ENTRIES MUST BE RECEIVED BY NOON ON SATURDAY, MARCH 17, 2012.

# Assumption of Risk Agreement

**I am aware that the activities I partake in may be HAZARDOUS ACTIVITIES, which are inherently dangerous and can carry significant risk of personal injury, death and/or property damage.**
