#### 3. Accommodation (World Cup Rules Art. 13)

- Booking according to the FIS Rules via FIS Online registration system
- The OC offers following accommodation in four stars modern and beautiful hotels (all full board):
- Clarion Grandhotel Zlatý lev\*\*\*\* 72 EUR per person/night (Accreditation, Race office, TCM, shuttle). Limited number of rooms (free capacity for aprox. 100 people first come, first serve)
- Hotel Babylon\*\*\*\* 75 EUR per person/night (aqua park, wellness, shuttle)

Deadline until December 1<sup>st</sup>, 2012. For room cancellation after January 2<sup>nd</sup>, 2013 the FIS World Cup Rules point 8.6 applies.

- Price for additional single rooms outside of the quota: 100 EUR

#### 4. Transport (World Cup Rules Art. 11)

Official airport: Prague Airport-Ruzyne One transport per team is free according to FIS rule 8.4.

Price for additional transport:

Transports from Prague Airport to Liberec can be organized by the OC on request.

Price list transport Prague Airport – Liberec / Liberec – Prague Airport:

1-4 persons – 100 € (personal car – one way)

5-7 persons –  $160 \in (minivan - one way)$ 

8-40 persons  $-270 \in$  (bus – one way)

Payment conditions: cash only during accreditation

Transport requests have to be sent to the OC until December 20<sup>th</sup>, 2013 The transportation between the hotels and the stadium will be provided free of charge by the organizer on request.

# 5. Payment (World Cup Rules Art. 10 and 13)
