1. Accreditation

- The FIS season accreditation will be valid. Requests for additional accreditation and parking cards must be sent via the FIS Online System.

- Requested additional accreditation and parking cards can be picked up at :
Accreditation office (Head Quarter Tschierov opening time daily from 09:30 to 17:00)

2. Race Office

- Race office in Tschierov (school building on the race area) opening time daily from 10:00 to 18:00

3. Accommodation (World Cup Rules Art. 13)

- Booking according to the FIS Rules via OC (Responsible is Stephanie Albertin).
- The OC offers following accommodation:
 - Hotels: 125 CHF
- The final size of the team and number of rooms must be given before December 19th. For room cancellation after December 19th, 2012, the FIS World Cup Rules point 13.2 applies. This means that the respective National Ski Association has to pay the difference between effective and reserved rooms (tolerance 10%).

4. Transport (World Cup Rules Art. 11)

- Teams are responsible during Tour de Ski for their own transport
- Information regarding Shuttle service
Hotels – venue: shuttle service in the valley, details will follow on-site.

5. Payment (World Cup Rules Art. 10 and 13)

- Financial conditions apply as stated in the FIS World Cup Rules. The teams are requested to pay all their hotel expenses for all team members - including Red Group athletes and eligible coaches directly at the hotel
- The organisers pay for **the travel and living costs** (accommodation, food etc.) according to the conditions mentioned in the World Cup rules.
Travel costs will be paid once and by bank transfer by the organisers to the teams at the last resort. The **Red Group List and their qualified coaches get free accommodation**, for at least two nights before the first FIS TOUR DE SKI competition until at least the morning after the last FIS TOUR DE SKI competition.

6. Waxing facilities (World Cup Rules Art. 14)

- Wax cabins: available from 31/12/2012 at 08:00
- Waxing trucks: teams arriving with trucks have to inform the OC before 06/10/2012

7. Regulations of radio equipment

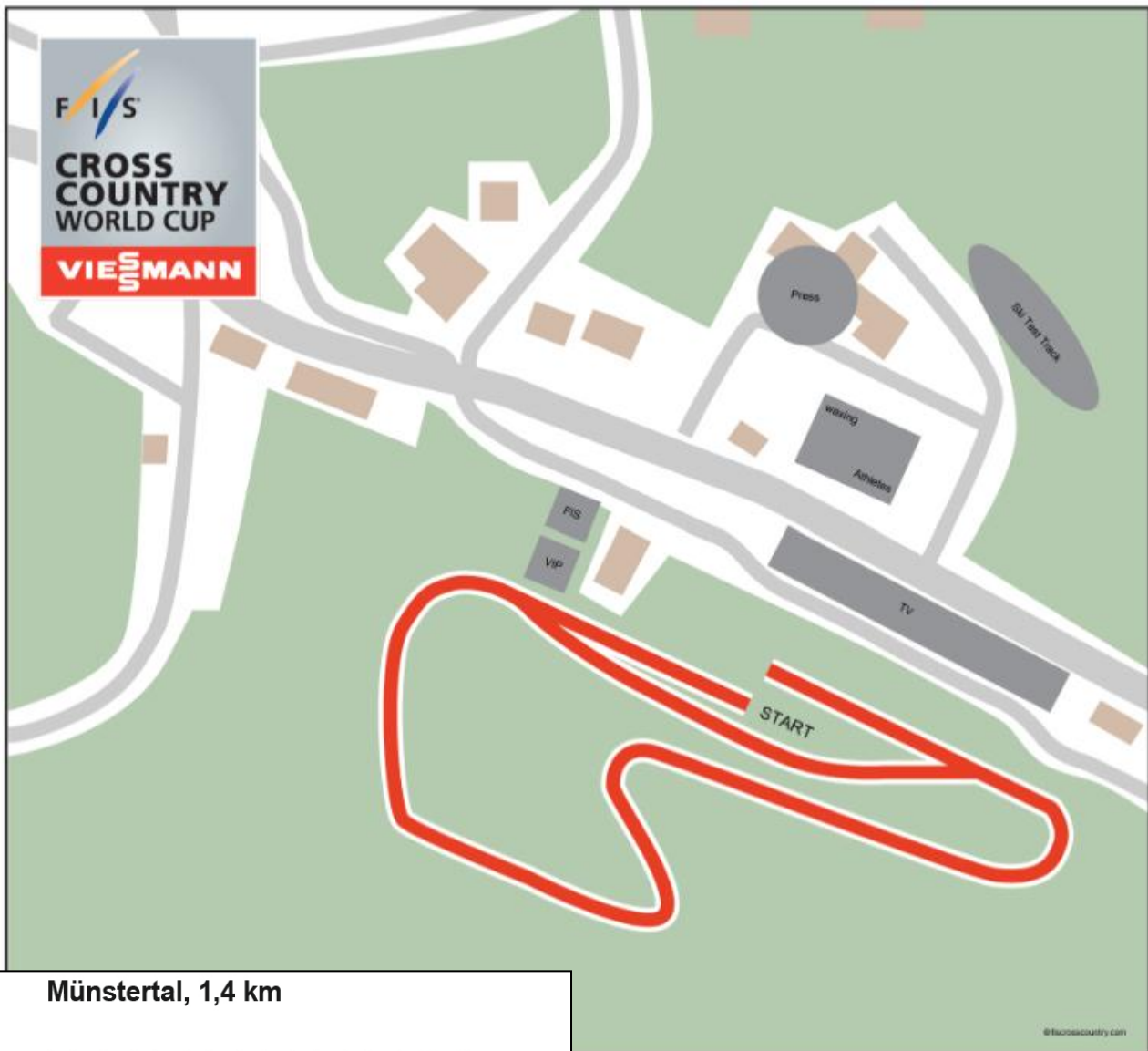
- The import, export and the operation of radio equipment in Switzerland is regulated by national law. Permits for the use of radio transmission equipment must be requested according to national specifications.

8. Regulations of Visa

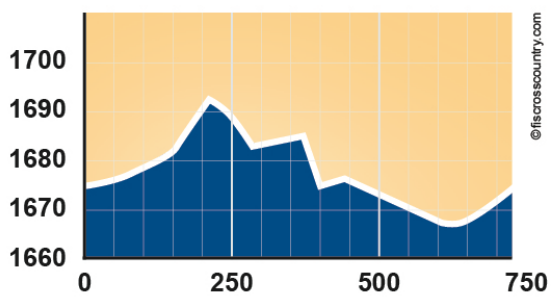
- Remember that citizens of some countries will need visa for visiting Switzerland. Please check with your embassy if you need a visa for Switzerland.
