### INVITATION

#### *Dear National Associations!*

On behalf of the Organizing Committee we are glad to invite all National Associations to attend the **AUDI FIS Freestyle Ski World Cup – Ski Cross in Kreischberg/Murau** which will be held **January 24<sup>th</sup> - 25<sup>th</sup>, 2014**.

The Organizing Committee will host the event in accordance with the International Ski Competition and World Cup Rules 2013/2014. All national Ski Associations affiliated with the FIS are invited to compete.

#### **1/ PROGRAMME**

You will find enclosed the provisional schedule of the event according to the FIS calendar. The Organizing Committee reserves the right to modify this schedule, depending on the snow conditions or/and the decision of the competition jury. The Draw will occur at Thursday, January 23<sup>rd</sup>, 2014 at 16:30-17:00.

#### **2/ ARRIVAL**

Please note that the appointment for welcome, information & accommodation will be at the Tourist Office (300 Meters from the event area) on Tuesday, 21<sup>st</sup>, between 09.00 and 08.00 pm.

#### **3/ ACCOMMODATION**

Teams will be accommodated in several hotels on half-board basis from Tuesday 21<sup>st</sup>, to Saturday 25<sup>th</sup>, at FIS rate according WC Rule 4.4. Payment in full (100%) **upon registration** (Cash or Credit Card – MasterCard/Visa) in the tourist office.

Each team will be held responsible for any damage incurred during your stay. Any kind of extras like phone, laundry, minibar, pay-tv, etc. must be paid by teams or athletes direct in the hotel.

Please, fill in your accommodation needs on the FIS Online Update System (Team size, Names, FIS Codes, and Gender) before December 15<sup>th</sup>, 2013 and a completed rooming list with any requirements about rooms & place sharing before January 16<sup>th</sup>, 2014.

#### **4/ ENTRIES**

Entries will be accepted from National Ski Associations following FIS quotas and rules.

Please submit the provisional entries of your competition team (including competitors and officials) and the names of participants by December 15<sup>th</sup>, 2013.

The final number of your competition team (including competitors and officials) and the names of participants must be submitted to the organizing committee no later than Thursday 16<sup>th</sup>, January.

Access to the online registration system is accessed through the FIS Homepage <http://www.fis-ski.com> then Member Section.

FIS has established nation Quotas for World Cups. National Ski Teams can only enter World Cup Ski Competitors according to the Quota limitations. Competitors entered into FIS Freestyle Ski World Cups must have the minimum required FIS Freestyle Ski points in the respective valid FIS points list. The minimum FIS point requirements per FIS Freestyle Ski Cross World Cup event are :

Standards Requirements	/	Ski Cross FIS Points
Freestyle FIS Points		100

#### **5/ BIBS**

All competitors must wear their bibs during the official training, competition, flowers and awards ceremony after the race.

## 6/ INSURANCE - LIABILITY

Each competitor must have his/her own medical insurance. The Organizing Committee sponsors, suppliers, their agents, the FIS and the Austrian National Ski Association decline any responsibility for accidents, damaged or lost equipment during the event.

All athletes, officials and members of the National Associations who attend and participate in the event shall do so at their own risk. The OC, sponsors and suppliers, their agents, employees and volunteers shall not be responsible for any losses or injuries incurred or suffered by any athlete, official or other person in conjunction with the organizing or staging of the event.

## 7. ANTI-DOPING CONTROL

Anti-Doping Control may take place during the Event in accordance with WADA and FIS guidelines.

## 4. Transportation

Teams are responsible for their own transportation.
