



**FIS Freestyle Ski World Cup
Sweden March 8, 2014**



TEAM INVITATION

On behalf of the Swedish Ski Association, Åre Slalomklubb cordially invites your nation, as a member of the Federation Internationale de Ski (FIS), to participate in the FIS Freestyle Ski World Cup Dual Mogul competitions in Sweden, as a part of the 2014 FIS Freestyle Ski World Cup. The FIS rules will be applied to this competition.

REGISTRATION AND ENTRIES: Team Entries are only accepted using the FIS Online Entry System according to the Rules of the FIS Freestyle Ski World Cup 7.6.2. NSAs can enter using the FOU System on the FIS website via the Member Section: <http://www.fis-ski.com/> Entries will be accepted from National Ski Associations within the FIS quotas and rules. Please submit the anticipated number of your competition team (including competitors and officials) arrival date and time and the names of participants by January 27, 2014. The FINAL number, arrival date and time of your competition team (including competitors and officials) and the names of participants must be submitted to the organizing committee no later than February 28, 2014.

ACCOMMODATION:

Your application for accommodation must be submitted to the organisers through the FIS online registration system with a complete rooming list no later than February 28, 2014.

Furthermore the Organizers must be informed, at the latest, **5 days before the official arrival day about the names and arrival date and time of the team members**, eventual changes to the arrival date and the originally registered size of team. (incl. officials and service personnel according to art. [5.47.6.4](#)), as well as any eventual withdrawal from the event. If this is not done, the Organizer will invoice the costs incurred for cancelled accommodation.

Accommodations at FIS rate are for the dates of the program only (arrival day March 5, to departure day March 9).

World Cup Freestyle lodging has been arranged at the FIS determined rate, 50 CHF, [356351.70](#) SEK. The organizers are not responsible for teams staying at any other facilities than those noted above.

Rooms are assigned based on availability and will be available for check-in on Wednesday, March 5, 2014 at 16:00. Departure is on Sunday March 9, 2014 by 10:00.

Early arrivals and late departures are subject to availability and will be charged at the normal hotel rate.

Upon confirmation of your housing application, additional forms will be forwarded to you for completion as required by the organiser.

IMPORTANT INFORMATION

LIABILITY/INSURANCE - The organiser cannot be held liable for any damage or accident. All participants have to be sufficiently insured against accidents and illness by themselves or their National Federation.

ANTI-DOPING CONTROL — [Anti-Doping](#) control testing may be conducted in accordance with the rules and regulations set forth by FIS.

FIS LICENSE - All athletes are required to have a valid FIS license in order to compete.

NATION QUOTAS

FIS has established nation Quotas for World Cup competitions. National Ski Teams can only enter World Cup Moguls/Dual Moguls competitors according to the Quota limitations.

FIS POINTS

We would also like to remind you that competitors entered into FIS Freestyle Ski World Cups must have the minimum required [25 FIS Freestyle Ski points](#) in the respective valid [Moguls FIS points list](#). ~~One athlete per nation per gender can be entered that have between 25-50 FIS Freestyle Moguls FIS points. All other athletes need to have the minimum FIS points for FIS Freestyle Moguls World Cup events which are 50 FIS points.~~

PRIZE MONEY

The payment will be made electronically by bank transfer no later than seven (7) working days after the last competition, taking into consideration the local tax laws.

An itemized confirmation of payment will be provided to the competitor electronically.

Bank transfer fees and value added tax (VAT) are covered by the Organiser.

Please make sure that you have all necessary bank information so that the transfer can be made as soon as possible. All winners must bring a photo ID and fill in a special income tax document at the race office before their bank transfers can be made.

We are looking forward to welcome you back to Sweden, and hope you will enjoy your stay here.
