DSV Liability– Participants

1. Risk assessment and individual responsibility of participants (DSV):

By signing the DSV Athletes Declaration, necessary for obtaining their entries, participants explicitly state having knowledge of the competition-specific risks and dangers as well as accepting them. Furthermore, they declare being informed that they may suffer the extent of injury to life, body or health in the exercise of this skiing discipline. Finally, they commit themselves to carry out their own risk assessment, whether their individual abilities are sufficient to overcome the difficulties of the course or of the location and to inform of any safety concerns that they may have regarding the training and competition courses. With their start they express their suitability to manage the course as well as to cope with its requirements. In addition, in the DSV Athletes Declaration, they expressly confirm being responsible for the material and equipment used. These declarations are especially binding for this competition.

2. Fault of the organizer and its helpers/assistants:

If participants suffer damage or a loss during the competition and they are of the opinion that the competent organiser or its helpers/assistants are to be blamed for, they accept that these will be only liable for property damage loss in case of intent or gross negligence. This statement also applies to the assignee of the athlete. The participants agree to acquaint themselves with the current competition regulations. If a third party suffers damage caused by athlete's participation in the competition, they accept that a potential liability can meet them alone. It therefore serves their own interest to have sufficient insurance coverage.
