The Organizing Committee is pleased to invite all ski cross nations to attend the Audi FIS Ski Cross World Cup 2015 Arosa Lenzerheide, as part of the 2014-2015 FIS Freestyle Ski World Cup Tour.

The competitions will be held under FIS Rules and Regulations for the Audi FIS Ski Cross World Cup and are open to all National Ski Associations affiliated with FIS. All athletes must previously have signed the FIS Athletes Declaration Form in order to register and compete.

Registration/Entries

Entries will be accepted in accordance with the FIS quotas and rules. All entries must be done using the FIS Online Registration System, through the FIS home page: http://www.fis-ski.com/ "Member Section". Entries by mail or fax are no longer accepted.

<u>Deadlines for the Team Entries are:</u>

Preliminary Entries (ladies & men): December 28, 2014

Final Entries: January 29, 2015

Accommodation

According to the FIS Rules the rates are CHF 50.00/day per team member (athletes and team officials) for accommodation, including halfboard and has to be paid directly at the hotel. Accommodation at the FIS rate will be provided only for the period of February 3 – 8, 2015 (5 nights). Each team will be held responsible for any damage incurred during the stay. Any kind of extras must be paid by the teams or athletes themselves directly at the hotel.

"No Shows" will be charged to the National Associations directly at the Hotel.

to Arosa.

By car: Highway from Zurich to Chur and then about 45 minutes up a winding mountain road
