1. Accreditation

2. Race Office

4. Transport

- Shuttle service

5. Payments

- Accommodation costs: The OC will pay for persons within the quota according to FIS Rules. Costs for persons not in the quota and all extras are payable directly in the hotels.
- Carrying costs/Reimbursement: Reimbursement of Officials will be done at/ after the Team Captains' Meeting
- Way of payment: All payments will be done by bank transfer.

6. Waxing Facilities

- Wax cabins: available all weekend
- The **keys** to the cabins are available at the race office. The deposit is 50 €/ team. Key return also to the Sportbüro/Race Office, open until the end of the event on Sunday and from 08:00 on Monday morning

7. Radio Equipment Regulations

- NEW!! All the used frequencies have to be registered with and authorized by the regulatory authority. A fine of up to 4.000 € may apply for unregistered radios.
- Please make sure to fill out the attached registration form and send it back to fb.graz@bmvit.gv.at or office@ramsausport.com.
- Representatives of the authority will be on location during the World Cup to check if all radios are registered!

8. Visa Regulations

9. Prize money and taxes



Ladies and Gentlemen!

The trouble-free operation of radio systems and telecommunications equipment within Austria is our concern and our statutory duty under the Telecommunications Act 2003 (TKG 2003).

To ensure trouble-free operation of radio systems, make sure that all used frequencies are coordinated and the operation of such radio systems are approved by the Telecommunications authority. Especially at major events in metropolitan areas, we need our regulatory law, and our right to intervene if necessary to comply consistently with unauthorized radio systems operated in the interest of all spectrum users.

The operation of radio stations in Austria is generally subject to approval. Excluded from a general understanding that only permits individual authorized radio systems. For example CB-radio (FSB-LN001), SRD-radio (FSB-LD074) or radio microphones (FSB-LD048).

Please remember that the operation may cause radio systems without frequency coordination and upright operation permit harmful interference to other stations and therfore inadmissible. We are mandated by law to take illegally operated radio systems out of service and confiscate in a row. Thereupon, an administrative **penalty procedure is done with a fine of up to € 4 000,**- including the forfeiture of the radio system to the public authority (§109 TKG).

We urge all users of radio equipment to contact regarding the use of these facilities in cojunction with the Telecommunications Authority.

The instructions of the telecommunications regulatory bodies of the radio monitoring Graz is to be **followed without**.

Handout regarding the disbursement of prize money at FIS Ski World Cup competitions in Austria valid from October 2013)

Each athlete, who receives prize money, has to present his/her passport (copy) – also valid for bank-transfer.

VAT applicable for prize money in Austria:

- An athlete participating at a FIS World Cup competition in Austria is liable to VAT regarding his/her prize money.
- Price money includes 20% VAT
- Legal regulation: sec 3a Art 6 UStG (Austrian Value Added Tax Act): a sporting performance is VAT charged at that place where the organiser (ASVG, ASN) is located.
- The organising management companies have to deduct and pay the international athlete's VAT to the tax authorities.
- Legal regulation: sec 19 Art 1 UStG (Austrian Value Added Tax Act): If the supplier of the service (=athlete) has neither domicile (seat) nor residence or a fixed establishment regarding the service supply in Austria, the service recipient (= organiser, e.g. ASVG, ASN) is liable to VAT. This applies if the organiser itself is a taxable entity.
- As a result, the international athlete does not have to take action (=pay VAT by her/himself) regarding her/his VAT liability in Austria.

Income tax - Withholding tax for international athletes in Austria:

- The Austrian organiser has to withhold 20 % of the international athlete's net prize money and pay it to the tax authorities.
- Legal regulation: sec 99 Art 1 lit 1 in connection with sec 100 EstG (Austrian Income Tax Act): the international athlete is subject to limited income tax liability, provided she/he receives remuneration for her/his service as a self-employed person.
- The organisers (e.g. ASVG, ASN, etc.) are liable for withholding and paying the withholding tax.
 They have to deduct the tax at that point in time when the prize money is disbursed to the athlete.
- Due to a special convention between Austria and USA, income tax will not be deducted by the
 Austrian organiser, if the athlete's income, including refunded costs, will not exceed
 US\$ 20.000,00 in Austria per annum. The US athlete has to proof his annual Austrian income
 by written documentation in order to obtain such tax relief.
- As a result, the international athlete does not have to take action (= pay Income Tax by her/himself) regarding her/his income tax liability in Austria.
