
8. Special permissions for truck driving


There is no need of special permissions for truck driving on Norwegian roads. No special rules and regulations, except for the normal Norwegian weather and snow conditions and the need of snow tires.


9. Income tax information for prize money:

- The current Norwegian tax rate for non resident athletes is 15%.
- Due to a special tax convention between Norway and USA and Russia, income tax will not be deducted by the OC "the income shall be taxable only in the State of which the sportsman is a resident"
- Tax will be deducted by the OC according to the Norwegian Foreign Artist Taxation Act, and taxes will be paid by the OC according to the regular tax legislation in Norway. The athlete may contact the International Tax Collection Authority skattvest@skatteetaten.no for a certificate confirming that the tax has been paid in Norway.
