Logistical information

Accommodation (World Cup Rules Art. 13)

- Booking according the FIS Rules via FIS Online registration system
- The OC offers following accommodation (full board included):

Radisson Blue Park Hotel (4 stars hotel 20 minutes from the venue)

Scandic Holmenkollen Park Hotel (4 stars hotel next to the venue)

Transport (World Cup Rules Art. 11)

- Official airport : Oslo Lufthavn Gardermoen
- The organizing committee will arrange transportation between the airports and the hotels. 1 transport (from and to the airport) free of charge. Price for additional transport: Euro 20 per person one way. The amount will be deducted from the reimbursement
- Shuttle transport is offered between the venue and Radisson Blu Park Hotel. Scandic Holmenkollen Park Hotel is in walking distance from the venue.

Reimbursement (World Cup Rules Art. 10 and 13)

Accommodation costs:

Over quota costs are to be paid by cash or credit card. The teams will pay for the accommodation in the financial office. Persons from the paylist will be paid



- directly. Team (Team Captains) will pay directly to the hotel for all extras (room service, movies etc)
- Carrying costs/Reimbursement :
 - Expenses sheets will be received in financial office during the race weekend or by e-mail: Payments will be done by bank transfer.

Prize money payment (Word Cup Rules Art. 8)

- Due to data protection rules the data's from the athletes have to be given directly to: gyro@holmenkolle.no or on-site to Gyro Conference in the reimbursement office (opening times see above)

Income tax information for prize money:

- The current norwegian tax rate for non resident athletes is 15%
- Tax will be deducted by the OC according to the Norwegian Foreign Artist Taxation Act, and taxes will be paid by the OC according to the regular tax legislation in Norway.
- The athlete may contact the International Tax Collection Authority at <u>skattvest@skatteetaten.no</u> for a certificate confirming that the tax has been paid in Norway.

Waxing facilities (World Cup Rules Art. 14)

- Wax cabins : available from 4/3/2019 at 12:00
- Waxing trucks: teams arriving with trucks have to inform the OC before 1/12/2018
- The keys to the cabins are available in the Service Building. The deposit is 100 €/team. Keys return to the office in the Service Building on the day of departure.



Regulations of radio equipment/Radio Frequencies:

- The import, export and the operation of radio equipment in Norway is regulated by national law. Permits for the use of radio transmission equipment must be requested according to national specifications.
