# OFFICIAL TEAM INVITATION

#### Welcome

The Organizing Committee is pleased to invite all ski cross nations to attend the Audi FIS Ski Cross World Cup 2018 Arosa Lenzerheide, as part of the 2018-2019 FIS Freestyle Ski World Cup Tour.

The competition now will be held on 11th December 2018 as a Ski Cross sprint event (postponement date 12th December 2018) - under FIS Rules and regulations for the Audi FIS Ski Cross World Cup and is open to all National Ski Associations affiliated with FIS. All athletes must previously have signed the FIS Athletes Declaration Form in order to register and compete.

#### **Registration/Entries**

Entries will be accepted in accordance with the FIS guotas and rules.

All updated entries must be done using the FIS Online Registration System, through the FIS home page: http://www.fis-ski.com/ "Member Section". FIS has established Nation Quotas for World Cups. National Ski Teams can only enter World Cup Competitors according to the Quota limitations.

#### **Deadlines for Team Entries:**

Preliminary Entries (ladies/men): October 31st, 2018

Final Entries: November 30th, 2018

#### Accommodation

According to the FIS Rules the rates are CHF 50.00/night per team member (athletes and team officials) for accommodation, including half-board and has to be paid directly at the hotel. Accommodation at the FIS rate will be provided for the period of December 9 - 12, 2018; 3 nights + 1 extra night in case of postponementof the event to December 12<sup>th</sup>, 2018. One single room per country for a team official will be provided. Each team will be held responsible for any damage incurred during the stay. Any kind of extras must be paid by the teams or athletes themselves directly at the hotel.

"No Shows" will be charged to the National Associations directly at the Hotel.

Important information: To accommodate all athletes, coaches and officials in a correct way, we do need your updated Preliminary Team Entries as soon as possible, October 31st, 2018, the latest. After the above mentioned Deadline for Team Entries the FIS rate for hotel accommodation can't be guaranteed anymore.
