# COVID-19 SITUATION

In order to ensure the health and safety for the athletes and team personel, the LOC is working in accordance with the Regional and National Health regulations as well as with FIS in accordance with the FIS COVID-19 Prevention Organiser Guidelines together with the World Health Organisation (WHO) information and recommendations. The LOC and FIS Event Task Force has been established and is monitoring all developments. The corresponding arrangements are currently being put together in a separate document. This will be published and communicated by the LOC

at a later stage. All competitors must have their own medical insurance (ICR art 212) which shall cover COVID-19 medical treatment expenses. Updated COVID-19 relevant medical procedures that may be required will be communicated whenever relevant. It'll be possible to conduct COVID testings on site for onward travels and needed test results.

At that point everyone connected to the event needs a negative COVID-19 tests not older than 72 hrs. when picking up the accreditation.

### GENERAL INFORMATION

Entries and important forms

Entries will be accepted from National Ski & Snowboard Associations in accordance with the rules for the FIS Freestyle Ski and Snowboard Junior World Championships (Rule 9 and accordance with the FIS quotas and rules).

Please submit your provisional entries as soon as possible and the final entries by **15**<sup>th</sup> **November 2020** using the FIS Online Entry System that is accessed through the FIS homepage:

We kindly ask you for a prepayment with the submission of the entries of the half of the participation fee. The rest of the participation fee will be required with the submission of the final entries!













To have the FIS rates, entries must not be sent to the Organizing Committee later than **15**<sup>th</sup> **November 2020** (Preliminary Entries) through the FIS homepage: <a href="https://www.fis-ski.com/DB/?authentication\_page=signin">https://www.fis-ski.com/DB/?authentication\_page=signin</a>

Due to the short number of available rooms in Lachtal the first teams to submit their entries will get the rooms in Lachtal, the other teams will be accommodated in Oberwölz.

Final Entries: 15<sup>th</sup> November 2020!

According to the FIS Rule on accommodation and half board, each participant will pay CHF 100/day directly to the Organizing Committee at the Registration. All National Teams should be aware that the amount in Euros might change according to the bank Exchange Rate on the day of payment.

Accommodation at FIS rate will be provided for the nights starting from December 17<sup>th</sup> 2020 to December 21<sup>st</sup> 2020 included. Each team will be held responsible for any damage incurred during the stay.

Any kind of extras like phone, laundry, minibar and pay-TV must be paid by the teams or athletes.

Reservations are only accepted with the Team Reservation Form.

Teams that will not book official accommodation will pay CHF 40/day/per athlete and staff and will receive package including participation fee, lift ticket.

### REGISTRATION

Teams registration will take place on Thursday, December 17<sup>th</sup> 2020 at Tourist Information in **Oberwölz** from 9 am till 6 pm. A timetable for the registration in order to follow the Covid guidelines.













### **BIBS**

All competitors must wear bibs during all official training, competition and award ceremonies.

### **ANTI-DOPING CONTROL**

Anti-Doping control testing may be conducted in accordance with the rules and regulations set forth by FIS.

### **ACCIDENT INSURANCE**

Each competitor must have his/her own medical insurance. The Organizing Committee, Union Oberwölz Lachtal, ÖSV, Lachtal

Seilbahnen Gmbh & CoKG suppliers, their agents decline any responsibility for accidents, damaged or lost equipment and 2<sup>nd</sup> and 3<sup>rd</sup> party claims during the event. All athletes must have previously signed the "FIS Athletes Declaration" form in order to register.

### LIABILITY

All athletes, officials and members of the National Associations who attend and participate in the event shall do so at their own risk. The Organizing Committee, Union Oberwölz Lachtal, ÖSV, Lachtal Seilbahnen Gmbh & CoKG FIS, sponsors and suppliers, their agents, employees and volunteers shall not be responsible for any losses or injuries incurred or suffered by any athlete, official or other person in conjunction with the organizing or staging of the event.

Teams are responsible for their own transportation


