## FIS SNOWBOARD WORLD CUP 2020 SIERRA NEVADA

MARCH 03-08, 2020

### 1. ENTRIES

Entries will be accepted from National Ski Associations following FIS quotas and rules. Please submit the anticipated number of your competition team (including competitors and officials) and the names of participants by the 26th of January, 2020 as per rule 5.6 in the Rules for the FIS Snowboard World Cup.

The final number of your competition team (including competitors and officials) and the names of participants must be submitted to the organizing committee no later than the 25th of January, 2020 as per rule 5.6 in the Rules for the FIS Snowboard World Cup.

### 4. ACCOMMODATION

Accommodation Teams will be hosted for lodging and meals at different partner hotels as per the FIS Snowboard World Cup rules, from Tuesday 3<sup>rd</sup> of March to Sunday 8<sup>th</sup> of March. Earlier arrivals or later departures than the official arriving/departure day do not guarantee the FIS rate.

As per the FIS Snowboard World Cup Rule on accommodation and half pension, all competitors and team officials will pay the Euro equivalent of 80 Swiss Francs per day. Each coach has to pay his/her team accommodation expenses by credit card. No reservation and no payment will be accepted from the competitors. Each team will be responsible for any damage incurred during their stay.

The payment of the Accommodation must be done directly to the OC – accommodation, before arrivals by credit card or by bank transfer.

The Organiser must be informed at the latest 8 days before the first TCM about the names of the team members, changes to the arrival date and the originally registered team size. If this is not the case, the OC is allowed to invoice the costs for cancelled accommodations to the respective NSA.

## **5. PARTICIPATION FEE**

According to the FIS Snowboard World Cup Rules, a mandatory participation fee of CHF 30 per official training, qualification and competition day will be charged. Total costs per competitor will be CHF 90.

All participants must be sufficiently insured against accidents and illness by themselves or their National Association. In addition, the aforementioned parties will take no responsibility for missing belongings.

## **9. ACCIDENT INSURANCE**

All competitors participating in FIS events must in accordance with ICR Art. 212 carry accident insurance and liability insurance, in amounts enough to cover accident, transport and rescue costs. The National Associations are responsible for adequate insurance coverage of all their competitors.

The National Ski Associations or their competitors must be able to show proof of the respective insurance coverage at any time on request of FIS, one of its representatives or the organizing committee.

Each competitor must have her/his own medical insurance. The Organizing Committee of Sierra Nevada as well as the sponsors, suppliers, their agents and the FIS decline any responsibility for accidents, damaged or lost equipment and second and third party claims during the event.

All athletes must have previously signed the "FIS Athletes Declaration" form in order to register.



## **10. ACCIDENT PROTOCOL**

In the case of accidents on courses during the event, the medical personnel from the Organizing Committee and the Ski Patrol personnel will be responsible for any medical decision or evacuation to the local hospital in cooperation with the National Associations medical personnel identified on the entry form.

## **11. ANTI-DOPING CONTROL**

Anti-Doping control testing may be conducted in accordance with the rules and regulations set forth by FIS.

## **12. FINANCIAL INFORMATION**

### **PRIZE MONEY**

According to the Spanish law, the rate for sport performance is 19% for residents in the European Union, and 24% for non-residents in the European Union.

The prize money will be transferred to the athlete account. The winners must go to the Race Office to complete and fulfill the following information: account holder's name, account, name of the bank, bank's address, bank's account, IBAN, SWIFT. The payment will be completed after the Organizing Committee receives the full and correct payment details of the prize money recipient.
