Please submit the provisional and final entries with a FIS Entry Form (ICR Art. 215) to Lyndsay Gang at Lyndsay.gang@usskiandsnowboard.org. Final entries must be submitted no later than 14 days prior to the first day of official training.

Provisional Entry Deadline: January 7, 2020

Final Entry Deadline: January 21, 2020

2. ACCOMMODATIONS

4. ONSITE REGISTRATION/ACCREDITATION

Registration and Accreditation will be held in the Mammoth Conference Center (MCC). Please see schedule for registration times. All competition participants (including competitors and officials) must report to the Registration Area for check-in before proceeding to the competition venue. All fees will be collected upon check-in.

Registration Fee: \$125 USD

Discounted training tickets for athletes will be available for \$52 (ages 13-22) & \$63 (ages 23+). Athletes will receive complimentary lift tickets for all competition days.

All Coaches with current FIS memberships and included within the official team entry will receive complimentary lift tickets for training and competition days.
