# COVID-19 Prevention Guidelines and Recommendations for teams for the AUDI FIS Ski World Cup Saalbach Hinterglemm from 5<sup>th</sup> to 7<sup>th</sup> March 2021 Update from 22 February 2021

Due to the COVID-19 pandemic, the **AUDI FIS Ski World Cup Saalbach Hinterglemm organised from 5**<sup>th</sup> **to 7**<sup>th</sup> **March 2021** has to take place under tight security measures. Based on the current regulations published by the Austrian Federal Ministry of Health and further measures taken by FIS and the Austria Ski Veranstaltungs GmbH, as the organiser of the event, we would like to present the following catalogue of measures to all teams published on 22<sup>th</sup> February 2021. We kindly ask you to forward this information to all team members (athletes, coaches, staff, NSA officials etc.) registering for the event via the FIS platform. By registering for this event, each team member fully confirms and accept the content of this catalogue of measures for the above-mentioned event.

#### Important information:

- Take responsibility
- Follow hygiene measures (regularly wash your hands and disinfect)
- Maintain at least 2 metre distance from others wherever you go
- Wear a FFP2 Mask
  - within the entire event venue; exceptions:
    - when drinking or eating
    - o athletes during sport
    - athletes in the start and warm up area during race preparation
  - in closed rooms
  - when using any type of transport such as buses, shuttles, gondolas and chair lifts
  - in the common spaces of accommodation

As the organiser of the event, we are obliged to limit the number of accredited people due to the COVID-19 situation. Therefore, only team officials are granted access to team and sports relevant areas, in line with the respective FIS quotas. People outside the applicable FIS quota are not allowed to enter the above-mentioned areas and do not have the possibility to stay at accommodation exclusively booked for teams!

#### **NEW Entry requirements to Austria:**

Due to the COVID-19 pandemic new entry regulations are valid for Austria with immediate effect! The following measures are necessary when travelling to the Austrian FIS World Cup events on business reasons:

- Letter of confirmation from your NSA that you are a professional athlete / coach / staff.
- Invitation letter from the Austrian ministry for your planned competition (Attached you will find this letter "Nationales Interesse Saalbach")
- Medical certificate or test result (Antigen or PCR) which confirms that you are negative tested on Covid-19 (not older than 72 hours). The test result (in German or English) must include:
  - Surname and forename of the tested person
  - Date of birth
  - Date and time of the test
  - Test result with stamp of the doctor or institution



Your entry is in the compelling interest of the Republic of Austria and you do not need to do the online-registration through the Pre-Travel-Clearance by exception mentioned in § 7(1) or § 8 of the Covid-19 entry regulation

In case the above-mentioned contents can not be presented upon entry the generally applicable obligation of a quarantine of 10 days in Austria will apply accordingly. The exemption regulation is only valid for work-related arrivals of persons required for the realization of the event - AUDI FIS Ski World Cup Saalbach Hinterglemm in March 2021! We would like to point out that the documents submitted may only be used for the above-mentioned group of persons and that passing them on to third parties is expressly prohibited!

### **Arrival at Saalbach Hitnerglemm**

- Do not arrive at the venue when showing COVID-19 symptoms.
- Avoid stops between your place of departure and the event location.
- Avoid contact with other people, especially outside your team.

#### Accreditation/race office

- Every team member officially named by the respective national ski association via the FIS
  online system is obliged to present a negative PCR test not older than 72 hours. The PCR test
  presented needs to be recognised by the health authority of the respective country! The
  corresponding test protocol needs to be uploaded to the FIS Passport platform at least 12
  hours prior to arrival.
  - Together with the test protocols, you need to name at least one contact person (team captain or team doctor) including contact details (name, mobile phone number, email address) please provide this information via the FIS Online Entry System.
- If individual team members are present at the event for 6 days or longer, an additional test PCR test is necessary in line with the 72h regulation. Example: If the PCR test was taken 48h prior to arrival, the respective person needs to be tested again on day 4 of the event. Test possibilities are available in Saalbach Hinterglemm.
- Only after presentation, examination and documentation of these documents will the
  accreditations be handed over to the team captain or a person appointed in advance and will
  the team members receive the keys to their rooms.
- Only the team captain or **one** representative of the team is allowed to collect all accreditations for the entire team.
- Members of the accreditation/race office either wear a FFP2 mask or they are structurally separated (spitting protection).

#### Hotel

- The LOC has reserved appropriate team accommodation.
- Currently, the hotels are mostly reserved for athletes and officials according to the FIS quota for the time between the official date of arrival (2<sup>nd</sup> March 2021) and the official date of departure (08<sup>th</sup> March 2021).
- In the event of team members arriving early or departing later, please inform the LOC immediately by sending an email to c.bauer@saalbach.com.
- Wear a FFP2 face mask in all public areas.
- A FFP2 face mask is always mandatory in the buffet area but it can be taken off at the table.
- Further hygiene measures may be displayed at the hotel.



- Check-in for all team members via team captain.
- Maintain minimum distance of 2 metre in all areas.

# Transport from accommodation to venue

- Please use team buses or vehicles as means of transport.
- Avoid stops between the hotel and the venue.
- For teams, only use the allocated and marked parking area (red parking area). When entering the parking area, only persons accredited for the red zone may be in the vehicle. The car park is located at the short gondola 12er EXPRESS with the address Schwarzacherweg 455, 5754 Hinterglemm.

#### Venue

- Maintain the minimum distance!
- Only stay in allocated and marked zones for teams (red zone).
- The team zone (red zone) is locked and can only be accessed by respectively accredited persons.
- Avoid direct contact with other teams.
- Avoid direct contact with members of the press.
- Please wear a FFP2 face mask at the venue at all times. Exceptions:
  - Athletes during sport
  - When drinking or eating
  - o In the start and warm up area athletes do not need to wear a face mask, however, it is mandatory for coaches, staff and officials.
- Food and drinks will be provided in the team hospitality area.
- Please only sit with team members in the team hospitality area (no contact with other teams)
- Please only ride the chairlift/gondola with your own team members. The number of permitted persons is indicated at the entrance. FFP2 mask is mandatory to wear during the entire ride.
- In case of a team member feeling not well or showing COVID-19 symptoms, please inform
  the LOC immediately by calling the Single Point of Contact on +43 664 815 2990. This number
  can be reached 24 hours a day from the official day of arrival until the official day of
  departure.
- There is an isolation room provided in close proximity to the venue in case you show symptoms.

#### Mixed zone/media

- TV and radio people as well as members of the press must maintain a minimum distance of 2 metre to athletes.
- TV and radio people as well as members of the press must wear face masks during interviews
- The number of media representatives will be extremely limited in coordination with the FIS.

#### **Team Captains Meeting (TCM)**

• The procedure of the TCM will be communicated by the FIS.

## **Doping tests**

- Athletes, medical staff, team doctors and chaperons must wear a FFP2 mask for the entire duration of the doping test.
- Wash hands and disinfect after testing.



#### **COVID-19 communication**

- If you show COVID-19 symptoms, please inform the LOC immediately by calling the Single Point of Contact on +43 664 815 2990.
- The LOC will activate measures according to the COVID-19 suspect case management.
- Any communication related to COVID-19 has to be coordinated with the FIS and the LOC.

#### Leisure activities during your stay in Saalbach Hnterglemm

- During all leisure activities, please respect COVID-19 measures such as maintaining physical distance, wearing a face mask, hygiene and avoiding contact.
- Restrict your leisure activities to necessary purchases and tasks that cannot be postponed.
- Spend your free time only with members of your team or your small group.

## Daily health check

- Furthermore, the medical confirmation below (according to Appendix 1), which is required by the authorities in Austria, must be completed and signed by each team at the accreditation.
- Prior to every training session and competition, every team member must fill in the daily health check and provide it to the LOC. <u>Therefore, please scan the QR code of your</u> <u>accreditation every morning and fill in the respective questionnaire online.</u> This is mandatory for all team members!

# Leaving Saalbach Hinterglemm between the official date of arrival and the official date of departure

• In the exceptional case of anyone needing to leave the Saalbach Hinterglemm region after arrival and before departure, this must be communicated in writing to the administration office (m.hirner@saalbach.com).

In order to minimise the risk of infection, the LOC makes the following recommendations:

- Form small groups
- Avoid contact with other teams
- Avoid contact with staff members of the LOC
- Avoid contact with tourists/fans
- Wear a face mask and maintain the minimum distance to journalists during interviews
- Regularly wash your hands and disinfect
- Document your physical condition

We ask EVERYONE, to TAKE RESPONSIBILITY and comply with all the measures and recommendations listed above! There will be stewards in place to check and enforce the COVID-19 guidelines. Please follow the instructions of the staff for your own safety and the safety of others.

In case of violation or non-compliance with the COVID-19 guidelines, we reserve the right to exclude you from the event and take legal action.

The measures were determined in accordance with the current regulation, last updated on 22<sup>th</sup> February 2020. The organiser reserves the right to make necessary changes, which will be announced immediately.
