# **HEALTH & SAFETY PROTOCOLS**

# Following protocols were established by LOC in association with FIS and ÚVZ SR

Up to this day, the protocol guidelines are following:

- Limit as much physical contact and interaction as possible by establishing sanitary bubbles.
- Create a sealed off race area with very strict health and safety protocols.
- Adhere to physical distancing protocols and protective measures (masks, disinfection, hygienic gloves) everywhere.
- Wearing a mask is required at all times, in every area both indoors and outside.
- Every participant being included in any of sanitary
  - bubbles has to undergo testing (RT-PCR test)
  - More information in "Testing Manual"
- In case of violation or non-compliance with these Covid-19 guidelines,
- the organizer reserves the right to exclude you from the event and take legal action.



# CURRENT COVID-19 SITUATION IN SLOVAKIA

### **Current** measures

- From 17 February 2021 the Public Health Authority of Slovak Republic announced new measures including:
- Individuals must maintain at least 2 meters of social distance everywhere.
- Wearing a mask is mandatory everywhere.
- Nightclub, casinos, restaurants (takeaway allowed, ban on alcohol sales), cafes, bars, fitness centers as well as cinemas and theaters, etc. will be closed
- An obligation for stores to display a notice of maximum number of customers allowed to enter.

# **ENTRY TO SLOVAKIA**



Every person entering the territory of Slovakia and presenting following documents at the border control does NOT need to go to isolation:

- negative RT-PCR test result no older than 72h (72 hours validity starting at the moment of receiving negative result)
   <u>BUT</u> keep in mind that to entry the event area, the RT-PCR test result, <u>no older than 24h</u> (from receiving the negative result) is required
- the invitation letter (provided for every accredited member by LOC) - printed or dowloaded into phone



# **ENTRY TO SLOVAKIA**

### for people who overcame Covid-19 in past 90 days



- In case of overcoming Covid-19 no sooner than 90 days before arriving to Slovakia, the participant entering Slovakia with following documents does NOT need to go to isolation:
  negative RT-PCR test result (no older than 72h)
- AND
- the invitation letter (provided for every accredited member by LOC) - printed or dowloaded into phone.



**Distancing** Always maintain proper physical distancing.




Safety & Hygiene Do not interact with general public (autographs and selfies are strictly forbidden).

Confinement Stay withing one's sanitary bubble and avoid all unplanned or unsafe outside contact.




Transparency Alert the doctors and organizing committee shall any known Covid-19 symptoms appear. Identify any contacts at risk.



Ventilation Ventilate any and all enclosed spaces frequently.

# **PRE-EVENT** behavior

- Every participant of organizers and media sanitary bubbles (LOC member, personnel, volunteers, supplier etc.) takes responsibility for own behavior 14 days prior arrival to the event and will confirm it by signing acknowledgement upon arrival (see next page).
- The participant shall respect all the regulations and recommendations of National Health Authority and if possible, will NOT attend any mass events (even going to cinema etc.).



I also declare that the result of the Covid-19 test, which I turned in upon arriving at the "Event" venue, is valid - I personally passed it at the time indicated on the confirmation.

I have been provided with protocols and guidelines for behavior at the "Event" and its venue (especially for protection against Covid-19), which I have read, understand and will follow.

I am aware that in case of violation of the protocols and regulations applicable to the "Event", the organizer reserves the right to exclude me from the event (without the right to any agreed wages), draw legal consequences and take legal action in the matter.

# **ARRIVAL TO THE EVENT**

- Any person showing known symptoms of Covid-19, as well as all other passengers traveling in same vehicle with such person, will not be allowed to the venue.
- Avoid stops between your departure point and the event location.
- Avoid contact with other people, especially outside your team.



# **GENERAL TESTING**

### and accreditation policies

- Strict adherence to ÚVZ SR protocols and guidelines.
- To be able to pick up accreditation, one needs to present:
  - negative RT-PCR test result, no older than 24h (24h validity starts from time of receiving the negative test result) and take AG test upon arrival to event area

OR

- if it is not technically possible, present negative RT-PCR test result, no older than 72h (72h validity starts from time of receiving the negative test result) and take AG and RT-PCR test upon arrival to event area.
- Turn in a filled out and signed FIS questionnaire to pick up one's accreditation (see page 17). FIS questionnaire will be send in advance and also available at testing points if needed.
- For more information see "Testing Manual"
- In case of violation or non-compliance with any of these policies, the organizer reserves right to exclude you from the event and take legal action.



## COVERING COSTS for tests

- In case you fail to present RT-PCR test result, no older than 24h and therefore you will have to undergo RT-PCR (in addition to AG test), this on site RT-PCR test is to be paid by tested person.
  - Athletes and teams arriving to event area on March 1 and 2, need to <u>re-take AG test</u> 72h from the time of entry test. This AG test is to be <u>paid by tested person</u>.
- Athletes and teams arriving on March 3 and later do not need to re-take AG test after 72h.
- If you require the exit RT-PCR or AG test, this is to be paid by tested person.

# Participants who overcame Covid-19 in past 90 days

- Participant, who passed last 90 days in Slovakia:
  - In case of overcoming Covid-19 no sooner than 90 days before the official departure date from event area, present certificate of overcoming Covid-19.
  - Take AG test upon arrival to event area.
- Participant traveling from outside Slovakia:
  - Present negative RT-PCR test (no older than 72h). If your test result is positive, show Covid-19 antibodies test result instead.
  - Take AG test upon arrival to event area.



# **Participants vaccinated against Covid-19**

- Participants vaccinated against Covid-19 <u>no later than</u> <u>14 days</u> prior to entering Slovakia by **BOTH SHOTS** need to present their vaccination card.
- Participants vaccinated against Covid-19 <u>no later than</u> <u>14 days</u> prior entering event area by **BOTH SHOTS** need to present their vaccination card.
- Such participant do NOT need to undergo testing at the event area.



# **TESTING POLICY**

in case of leaving the event area


- Every time a participant shall leave the event area, one is obligated to contact Covid-19 Unit and present the accreditation to security worker at gate for them to deactivate access to particular zones.
- Coming back to venue, the participant is obligated to undergo AG test at the venue (after every entry!).
- If the AG test result is negative, access to zones will be re-activated.
- Exceptions staff accommodated in HVT and TV team accommodated in Limba, whose cars need to be marked clearly.



# **LEAVING THE EVENT AREA**

on official departure date

 It is obligatory for every participant to undergo Covid-19 test no sooner than 12h before official departure from venue (after event) by PHA of SR decree 45/2021, §4 par. (2)j). • If the mentioned test result is positive, follow national health ministry regulations.

## **TESTING PROTOCOLS by bubble**

### **RED SANITARY BUBBLE (RACE)**



To pick up one's accreditation

- 1. Present the results for **RT-PCR test** (no older than 24h prior arrival to event area) or documents by pages 15, 18 and 19 of this document /*The results must appear in one's FIS PASSPORT 12 hours before the accreditation retrieval area opens for the race sanitary bubble so that the COVID-19 medical coordinator can review and approve them/ and also result for AG test taken right after arriving to venue.*
- If it is not technically possible for you to present RT-PCR test result, no older than 24h, present negative **RT-PCR test result** (n<u>o older than 72h</u> prior arrival to event area) <u>and also</u> take AG and RT-PCR upon arrival to event area.

3. Turn in signed FIS Health Questionnaire.

## **TESTING PROTOCOLS by bubble**

### **RED SANITARY BUBBLE (RACE)**

#### During event

Every accredited participant from blue sanitary bubble is required to undergo AG test at the venue every 72h (March 1 to 8).

It is obligatory to undergo testing before departing the event area (no sooner than 12h):

• Turn in signed FIS Health Questionnaire.

#### After event

- 1. Sign in in advance via **ONLINE form.**
- 2. Turn in signed **FIS Health Questionnaire**.

# **TESTING POLICY**

#### in case of positive result

- If AG test taken at the venue is positive, conduct RT-PCR within 24h at the venue.
- While waiting for RT-PCR test, the participant will be located to isolation room.
- Isolation rooms will be reserved in every one of used accommodation buildings and the affected will be located to isolation room in one's particular accommodation building.
- If the RT-PCR is negative -> returning to the event is possible after remote medical consultation.
- If RT-PCR test is positive -> the participant stays in quarantine in isolation room or leaves the venue.
- In case of violation or non-compliance with any of these policies or event staff instructions, the organizer reserves right to exclude you from the event and take legal action in the matter.

# **DAILY HEALTH CHECK**

- On top of turning in the FIS Health Questionnaire (signed!) at the accreditation center and before every testing it is necessary:
  - Fill in "Daily Health Check" form online every day by 10AM.
  - Form can by access on website <u>https://</u>
  - www.worldcupjasna.sk/d or by scaling QR code on one's accreditation.
  - All of above mentioned is mandatory for <u>every</u> event participant and in case non-compliance, the organizer reserves right to exclude you from the event.

- Compliance with the following protocols will be monitored throughout the duration of the event, including its preparation.
- Only stay in zones marked for your bubble.
- Stick with your team and avoid contact with members of other teams.
- Wearing a mask is mandatory everywhere, except:
  - Athletes during the performance of sports
  - While consuming food and drinks
  - Competitors in the start and warm-up zone (does not apply to coaches, etc.)
- In case of violation of the protocols relating to the zones mentioned on the following pages of the manual, or non-compliance with the instructions of the event staff, the organizer reserves the right to exclude the participant from the event and take
   legal action in the matter.

### Accreditation:

- As the organizer of the event, we are obliged to limit the number of accredited people due to Covid-19 situation. Therefore, only team officials are granted access to team and sport relevant areas, in line with the FIS respective quotas. People outside the applicable FIS quota are not allowed to enter above mentioned areas and do not have possibility to enter accommodation booked for teams.
- All areas will be organized to limit the flow of people as much as possible.
- Foot traffic protocol, with a specific direction for traffic to follow, will be established for every sanitary bubble - access with particular accreditation only.
- Race bubble accreditation office in Hotel Grand Jasná (C1)
- Accreditation cards to be picked up by 1 person only (Head Coach / Team Captain), who will be the only one entering the accreditation office.
- Participants of organizers a media sanitary bubble (or head of their department) will
  pick up accreditation in World Cup Plaza (outdoor spaces cash registers C2). Particular
  pick-up points/windows will be separated by one empty window.
- 5-7 March, partners bubble accreditation in World Cup Plaza (outdoor spaces cash registers C2).

Use hand sanitizer frequently.

### Accommodation:


- If possible, team will be housed on the same floor (where shall not be other hotel guests). Access hotel amenities via stairs (to limit infection risk in elevator).
- Team Captain checks-in all team members.
- Maintain proper distance between twin beds, if possible.
- If possible, specific entrance for **RACE bubble** will be designed.
- Hand sanitizer will be available in mentioned areas.
- Housekeeping only on request and with no racers present (avoid all contact with housekeeping staff).
- Isolation rooms will be reserved in every one of used accommodation facility.
- Use only the room assigned to you by LOC.
- Particular accommodation facilities may have other hygienic protocols in addition to the ones mentioned in thus document.
- Respect rules for use of common areas (congress room,...).
- Max 2 people accommodated in one room.



### <u>Meals:</u>

- **RACE bubble's** dining room will be divided from dining areas for other hotel guests.
- Catering strictly adheres to health and safety protocols separate eating area for RACE bubble; buffet style meals NOT permitted (meals will be served strictly by catering employees or sealed) a beverages to be served in sealed bottles only.
- Enough water/beverages already on each table.
- Respect maximum table capacity.
- The 2m distance between tables will be kept.
- Use hand sanitizer frequently.





### Team Hospitality:


- All areas will be organized to limit the flow of people as much as possible.
- Foot traffic protocol, with a specific direction for traffic to follow, will be established.
- Limited the number of people in each area by m<sup>2</sup> per person. Right now, protocols call for 4 m<sup>2</sup> per person.
- Access granted for participants with FIS accreditation only.
- Catering that strictly adheres to health and safety protocols separate eating area for RACE bubble; buffet style meals NOT permitted (meals will be served strictly by catering employees or safely packed) a beverages to be served in sealed bottles only.
- The area will be cleaned frequently.
- Respect maximum table capacity.
- The 2m distance between tables to be kept.
- Access will be controlled at entrance.



### Waiting area/ Changing tent/ Warm Up tent:

- All areas will be organized to limit the flow of people as much as possible.
- Foot traffic protocol, with a specific direction for traffic to follow, will be established for every sanitary bubble - access with particular accreditation only.
- Limited the number of people in each area by m<sup>2</sup> per person. Right now, protocols call for 4 m<sup>2</sup> per person.
- Limited access of above mentioned ares for race and organizers sanitary bubbles only.
- No volunteers are allowed inside any of these areas (only outside/in perimeter, if their work enlistment requires them to
  - f.e. badge check).






### Start & Finish area:


- All areas will be organized to limit the flow of people as much as possible.
- Foot traffic protocol, with a specific direction for traffic to follow, will be established for every sanitary bubble - access with particular accreditation only.
- Limited the number of people in each area by m<sup>2</sup> per person. Right now, protocols call for 4 m<sup>2</sup> per person.
- Limited access of above mentioned areas for race and organizers sanitary bubbles only.
- Team hospitality (start area) will be located in Von Roll.
- Dedicated changing tent will be provided for the racers in finish area.






### Lift Access:

- Wearing a mask is required when riding a lift.
- Regulated lift access via corridors. Only one's assigned corridor (one for each sanitary bubble) to be used.
- Respect maximum chairlift capacity and maintain physical distance.
- Only participant from one sanitary bubble are allowed on same chairlift.
- The lift and all the other means of transportation will be disinfected frequently.
- Lift access granted to all sanitary bubbles except for green bubble (partners zone).
- Chairlift Koliesko-Lukova reserved for race and organizers bubble only and people with marked accreditation.
- During race bubble accession all other participants' access temporarily denied.
- Other lifts than chairlifts (f.e. poma/button lifts) to be used only by race and organizers bubble (access with particular accreditation only).





### **Doping control**

- Racers, medical staff, team doctors and chaperones are required to wear a mask throughout the duration of the doping control.
- Wash and disinfect hands afterwards.



### <u>Ski room</u>

- Located in every hotel, in which racers are staying.
- Dedicated box for each team.
- Wear mask at all times.
- Disinfect hands frequently.



### Radio Center:

- One volunteer assigned to the radios, mask and gloves required.
- Every participant (shall his work assignment require it) will be assigned own radio and charger.



### TV compound:

- Access the area with particular accreditation only.
- Provide enough hand sanitizer.
- Clean the mentioned area frequently and disinfect facilities thoroughly.



#### Entertainment:

- All entertainment and side events have been restructured as online events.
- Spend your free time only with members of your team or in small group.



### FIS Family/ Partners and General public:

- FIS Family and partners may attend the event under condition of following all guidelines and regulations.
- Access designed ares with valid accreditation only.



### Race Office & Team Captain meeting:

- Race Office access for race bubble only.
- TCM reserved for the organizing committee, FIS personnel, doctors, race secretary and technical staff, Swiss timing, 1 representative per country, and 1 SRS representative.
- Access control at the entrance to the TCM
- No cocktails after the TCM.
- Program available online on the website after the TCM.
- Broadcast the TCM live.



### Media Center:

- All areas will be organized to limit the flow of people as much as possible access with valid accreditation only!
- Foot traffic protocol, with a specific direction for traffic to follow, will be established.
- Limited the number of people in each area by m<sup>2</sup> per person. Right now, protocols call for 4 m<sup>2</sup> per person.
- Access for media sanitary bubble only.
- Designed work space/seat bound to accreditation for every assigned participant. Use of any
  other than one's assigned seat is forbidden.
- Catering via food packages and sealed bottles.
- Eating and drinking allowed at one's designed work seat only.
- Wear a mask at all times, except the time required to eat or drink.
- The press conference will be held behind closed doors and broadcast on the website.
- Limited number of journalists during the event.
- In case of violation of these protocols or non-compliance with the instructions of the event staff, the organizer reserves the right to exclude the participant from
  - the event and take
  - legal action in the matter.



#### Jury room:

- Limited number of people present at the same time.
- 2 jury rooms: 1 at the Race Office (Hotel Grand Jasná) a 1 at finish area.
- Enough hand sanitizer will be provided.
- Clean the area frequently.
- Catering via food packages and sealed bottles.



### Bib draw:

• No public bib draw ceremony.



### Winner photos/Official Award Ceremonies:

- Awards ceremonies will be at the finish area after the races.
- Physical distancing between athletes and between the athletes and journalists during the podium photo.
- No handshaking when the trophies are awarded.
- The awards will be prepared for each one on particular podium, from where racers will pick it up themselves.
