The outbreak of the COVID-19 pandemic has affected every aspect of live for both business and individuals worldwide. Belarus Ski Union, FIS and Raubichi are happy that this year welcome you all back to the FIS Freestyle Ski Aerials Europa Cup.

The Freestyle Ski Aerials Europa Cup in Raubichi February 2nd-8th, 2021 will take place with enhanced safety measures. Based on the current directive by the Ministry of Health of the Republic of Belarus and exceeding measures by Raubichi as well as by FIS, we herewith send this measure catalogue to you all. By accepting the order and by registering with the accreditation system every individual accepts the content of this measure catalogue entirely.

2. BASICS AND GENERAL GUIDELINES

- Individual Responsibility;
- Hygiene measure (frequent handwashing, frequent disinfection);
- Maintain at least 1.5 metre of social distance wherever you go;
- Wearing a mask is required at all times, in any area, indoors mandatory and outdoors - recommended, except when: eating and drinking, staying in the hotel room, practicing sport, and for the athletes at the start and in the warming-up area;
- Remain in small groups;
- Avoid contact with other teams and other groups;
- During the leisure activities, always respect COVID-19 measures, such as: distancing, mouth-nose protection, hygiene;







- Limit your leisure activities to necessary only (essential food and medicine purchase, etc.);
- Spend your free time only with members of your team/group;
- Do interviews with journalists only with socially accepted distance and mouth-nose protection;
- Avoid contacts with tourists/fans;
- Protect the health of participating athletes and everyone involved in the event, as well as ensure that races go as planned.

Mouth-nose protection:

- All the staff will be wearing mouth-nose protection;
- All the teams and service providers will have to wear mouth-nose protection in the competition area.

We ask everyone to take full responsibility and comply with all the measures and recommendations listed above and in these Guidelines!

There will be stewards in place to check and enforce these COVID-19 guidelines. In case of violation or non-compliance with the COVID-19 guidelines, we reserve the right to withdraw your accreditation, exclude you from the event, and take legal actions.

The OC meetings and all communication work will be held as much as possible through the usage of phone, E-mail, and video conferences.

3. JOURNEY TO RAUBICHI

- Do not travel to the venue with symptoms of COVID-19;
- If people close to you have been affected with COVID-19, please contact your superior and refrain from travelling to the event;
- Avoid stops when travelling to the venue;
- Avoid contact with other people especially other team members;
- All the teams and service providers will have to wear mouth-nose protection during local transportation and Airport-Hotel-Airport transfer.







4. ACCREDITATION

- Due to the present situation we as organizers must limit the number of accredited persons. Please accredit only persons that are really working during the World Cup;
- Only one representative may collect all accreditations for their team or service providers;
- For FIS official and Media personnel they will receive their accreditation at the hotel where they will stay;
- Employees of the accreditation/race office wear mouth nose protection.

5. EVENT VENUE

- Keep minimum distance 1.5 metre;
- Stay only in the allocated and marked zones;
- For service providers and media: Please avoid direct contact to sports teams and wear mouth-nose protection. As well as avoid contact with other staff members and members of the press;
- When riding in the chair lift all persons must be of the same team or same working group.

6. HOTEL

In the restaurant you will be seated at a table where you will be served – no buffet area.

7. GYM

Gym will be possible according to the schedule for each team tba upon arrival.

The OC want to clarify that this area will not be staffed so it is up to the individual to make sure they disinfect the equipment after use.

8. COVID-19 COMMUNICATION

- In case of symptoms inform the OC (contact details will be announced) as well as your supervisor immediately;
- The OC will activate COVID-19 chain of measures;
- In case of symptoms there are isolation rooms available;







• All communication concerning COVID-19 must be discussed and agreed with FIS and the OC.

9. TO MINIMIZE THE RISK OF INFECTION THE OC RECOMMENDS

ALERT THE MEDICAL TEAM AND THE ORGANISING COMMITTEE OF ANY SYMPTOMS AND IN CASE OF THE POSITIVE TEST RESULT, IDENTIFY ALL CLOSE CONTACTS

10. FIS COVID-19 PASSPORT

The International Ski Federation-FIS introduced the FIS COVID-19 Passport for the season 2020/2021 for all Team and Media representatives.

Main four functions of the FIS Passport are the following:

- 1. Upload of the test result
- 2. Whereabouts for the last 14 days
- 3. Health Pre-Event questionnaire
- 4. Daily health questionnaire

Conditions to get accreditation for each person:

The following must be filled out in the FIS Passport by 10 a.m. on the day when accreditations are to be collected:

• uploaded negative COVID-19 PCR Test (saliva or swab test) result not older than 72 hours at the time of the accreditation pick-up or positive COVID-19 PCR-test between 90 days and 14 days prior to the time of the accreditation pick-up;







- filled out Whereabouts for the last 14 days;
- filled out Health Pre-Event Questionnaire;

The COVID-19 LOC Coordinator checks each registration and authorises issuing of an accreditation. Should there be any problem or in case of any doubts, the Team Captain will be immediately contacted by the COVID-19 LOC Coordinator and informed about what actions to be taken.

11. ADDITIONAL MEASURES

There will be no additional program.

We appeal to everyone to act RESPONSIBLE and to keep and implement all measures and recommendations! We will have stewards employed to control the compliance with the COVID-19 Guidelines.

The OC reserved the right for necessary changes which have to be announced immediately!
