

## **2021 COVID Event adaptations and testing requirements**

Dear World Cup Freestyle Mogul Teams,

We are honored and excited to welcome you back to Deer Valley Resort for the 2021 Intermountain Healthcare Freestyle International, part of the FIS Freestyle World Cup.

As we are all adapting to new environments this year, the Deer Valley World Cup LOC and local medical professionals have established event protocols and requirements for all teams, staff, volunteers and resort guests.

Further information regarding registration protocol and blocks will be administered in a timely manner prior to the event.

Please read the following pages carefully. We request that all teams abide by the following guidelines. Not following the guidelines could result in a removal from the event.

### **Arrival in the USA Prior to Sunday, January 31<sup>st</sup>, 2021**

- FIS Passport must have a negative PCR COVID-19 test within 72 hours of your first arrival date in the USA.
- Team member must have a negative PCR COVID-19 test within the period of Sunday, January 31<sup>st</sup> and Tuesday, February 2<sup>nd</sup> prior to 9 am local time, in order to receive a credential to the event. This result must be posted in their FIS Passport no later than Tuesday, February 2<sup>nd</sup> at 9 am.
  - The OC is providing testing on Monday, February 1<sup>st</sup> prior to 9 am, these results will be available prior to 10 pm on the same day. Cost is \$130 USD/person.
- All team members must have a 2<sup>nd</sup> negative PCR COVID-19 test in order to remain on the start list of their first event day or to have access to the venue. This negative test result cannot be older than 24 hours prior to the first event day. The result must be posted in your FIS Passport.
  - The OC is providing testing on Wednesday, February 3<sup>rd</sup> prior to 9 am, these results will be available prior to 10 pm on the same day. Cost is \$130 USD/person.

### **Arrival to Salt Lake City on Sunday, January 31<sup>st</sup>, 2021**

- FIS Passport must have a negative PCR COVID-19 test within 72 hours of your arrival to the Salt Lake City International Airport or Check in for lodging from the OC.
- Team member must have a negative PCR COVID-19 test within the period of Sunday, January 31<sup>st</sup> and Tuesday, February 2<sup>nd</sup> prior to 9 am local time, in order to receive a credential for the event. This result must be posted in their FIS Passport no later than Tuesday, February 2<sup>nd</sup> at 9 am.

- The OC is providing testing on Monday, February 1st prior to 9 am, these results will be available prior to 10 pm on the same day. Cost is \$130 USD/person.
- All team members must have a 2nd negative PCR COVID-19 test in order to remain on the start list of their first event day or to have access to the venue. This negative test result cannot be older than 24 hours prior to the first event day. The result must be posted in your FIS Passport.
  - The OC is providing testing on Wednesday, February 3rd prior to 9 am, these results will be available prior to 10 pm on the same day. Cost is \$130 USD/person.
- No one who presents symptoms that are associated with COVID-19 within 10 days prior to arrival will be allowed to be involved in the competition and should stay home.
- If an individual comes in close contact with a person of known exposure they are not to travel to the competition.
- All individuals are required to wear a mask or approved face covering at all times while in Utah. For more information on current COVID-19 guidelines in Summit County, UT please check [here](#).

#### **COVID-19 Testing and Positive case Overview:**

- Any participant (athlete, coach or official) who has tested positive for COVID-19 within 15-90 days from arrival date must present their positive test results in the FIS Passport and will be exempt from testing.
- All tests (once received) must be uploaded into the FIS PASSPORT system by the teams.
- If an athlete tests positive, the LOC will be required to report the positive test to the local health authorities ([Summit County Health Department](#)).
- The [Summit County health department](#) will tell anyone who was in close contact with the positive individual when to get tested. The World Cup LOC can help facilitate these tests. Only persons who came into close contact with individual who tested positive will be asked by public health to quarantine for 14 days. Close contact means someone was closer than 6 feet or 2 meters to a person who has COVID-19 for 15 minutes or longer.
- Individuals who test positive must isolate. They can't work, participate, volunteer, or travel until symptoms start to get better and they have been fever-free for three (3) days without medicine AND it has been at least 10 days since they first had symptoms or tested positive. A negative third PCR COVID-19 test will not test you out of isolation or rules set forth by the local health authorities.
- All athletes must complete symptom checks daily. Anyone who has symptoms outlined in the symptom checklist in the FIS PASSPORT system will not be allowed to train or compete.

# Testing Schedule

## **Moguls Team Testing**

All teams will be assigned a testing slot between 7:00 am-9:00 am. All teams must provide their own transportation.

Testing will be a Saliva PCR test located in the parking lot at:

Results will be provided to team leaders prior to 10 pm on the day of testing.
