Registration - Entries

Preliminary Team Entry Deadline: Saturday, December 26, 2020 / 26.12.20

*Please include all competitors and officials in preliminary entry

Final Room Configuration and National Interest Exemption Waiver Deadline: Monday, January 4, 2021 / 4.1.21

*Please include final number of competitors, officials, and lodging needs along with National Interest Exemption Waiver (where applicable)

Final Payment Deadline: Monday, January 25, 2021 / 25.1.21

*Please submit lodging payment via Square

<u>IMPORTANT</u>: All teams MUST identity a single team leader as the onsite contact when submitting team entry. This person will be responsible for communication to/from the OC prior to and during the event. This is extremely important to facilitate the new registration process, accreditation pick-up, and Covid-19 procedures.

Event Registration/Accreditation

PRIOR TO ARRIVAL:

- All Team entries must be submitted prior to the deadlines listed above. The team leader is responsible for all communication to/from the OC and submission of all documentation and waivers
- Submission of completed Event Liability waivers and accreditation requests
- Submission of National Interest Exemption Waivers
- Responsible for FIS World Cup Protocol Covid-19 related reporting (i.e. Test results, pre-screen questionnaire, daily symptom checks)

ONSITE ACCREDITATION:

• More information about onsite accreditation pick up will be communicated directly to the Team Leader. Registration and accreditation pick-up will conform with all local health authority guidelines







FIS World Cup Risk Management Covid-19 Testing Protocol

Responsibility of all Persons: In order to ensure the FIS World Cup and an event is not placed at risk from a Covid-19 outbreak and consequences, it is the responsibility of every person to adhere to this policy, follow all procedures and instructions and behave in a disciplined manner at all times. As referenced above, each Nation must designate one Team Leader to facilitate protocols, including reporting.

Testing prior to arrival at Event / Venue: Every person who wishes to access a FIS World Cup event must have and present a negative Covid-19 PCR Test (saliva/swab test) result carried out within the previous 72-96 hours (3-4 days) before arrival at the Event for the first time and complete a questionnaire. The test results must be recorded in the FIS passport system.

Testing on arrival and during the Event (training and competition days): PCR testing of FIS representatives, athletes, support staff and accredited personnel every three to four days is required. Persons arriving at the Event without a valid test result will not be permitted access to accreditation or the venue. The test results must be recorded in the FIS passport system.

Inbound Travel- National Interest Exemption Waiver

The Department of Homeland Security (DHS) has issued a National Interest Exemption to the existing travel restrictions for essential international staff and athletes participating in international sports federation events. Customs Border Protection (CBP) asks that we keep each entourage as small as possible. This exemption waiver will alleviate the need for any quarantine period when entering the U.S.

- The exemption provides access to the U.S. for individuals traveling from countries impacted by the geographic presidential proclamations. It will cover the entire Schengen region. (China, Iran, Europe's Schengen region, the United Kingdom/Ireland, and Brazil)
 - $^\circ$ *This also includes anyone that is transiting through these countries
 - **Individuals arriving from other countries who are not on this list do not require a waiver
- The waiver does not exempt individuals from standard entry requirements, including visa (B1 or B2 tourist/business), passport, and any other necessary documents
- All inbound travel must enter the US through the 15 designated airports (see next page)

National Interest Exemption Waiver will be distributed to the Team Leader after provisional entry is submitted. Waiver must be completed and accompany final entry due Jan 4, 2021/ 4.1.21

Accommodations

Accommodations for mogul and aerial athletes and officials are provided at various condominiums in the Snow Park Village, the base area of Deer Valley Resort. Condominiums will have fully equipped kitchens. Exact lodging assignments will be confirmed upon arrival and check-in.

At the time of check-in, a major credit card will be required to cover all incidentals. Each team will be held responsible for any damage incurred during their stay. All lodging accommodations are nonsmoking, NO EXCEPTION. The accommodations that teams will stay in are privately owned vacation homes. Athletes should be respectful of these properties. Please remove ski boots at the door. Occupancy is limited to one adult per bed in designated sleeping areas. Gatherings of any nature that exceed the occupancy limitations are prohibited. NO PETS. Additional housekeeping fees may apply at the discretion of Deer Valley Resort.

*Note: Lodging charges apply to all persons listed on the Team Selection Form as of Friday, January 8, 2021 / 08.01.21 regardless of whether they attend the event. Requests for lodging after this point will be at the discretion of the Organizer and fees will be based on prevailing rates (typically well in excess of the FIS rate). Payment must be made by Monday, January 25, 2021 / 25.1.2021 online via Square.

As per the FIS Rule 3.3.1 regarding accommodations, food and transportation, the venue will collect 20- CHF per person with no meal plan. Accommodations will be provided beginning the night of Monday, February 1, mogul teams departing the morning of Sunday, February 7, 2021 and aerial teams departing the morning of Saturday, February 6, 2021







Medical Plan/Anti-Doping

Medical Plan:

The Medical Plan will be reviewed at the first Team Captain's meeting, the LOC will send the Medical Plan to Team Leaders prior to the Team Captain's meeting.

Anti-Doping:

Anti-doping control may be conducted for each event and gender.
