5. ACCOMMODATION

Apartments/Rooms for all Teams and Officials are reserved at the Birkebeineren Hotel & Apartments,

The Organising Committee will cover the accommodation expenses according to the FIS Continental Cup SJ Nations' Quota for the summer 2020. For booked room reservations not used, the organiser has the right to demand a cancellation fee from the National Ski Associations according to FIS rules.

For additional persons or additional nights (above the quota) the price per person per night with full board is **NOK 1500 / CHF 150 / Euro 120**

6. TRANSPORT

Official airport : Oslo Airport

Bus transfer of the Teams from Oslo Airport to Lillehammer and return will be organised by the Organising Committee upon request from the Teams.

Bus transport will be organised Friday 13 September from Oslo Airport to Lillehammer. Return transport will be organised on Sunday 15 September from Lillehammer to Oslo Airport.

TRANSPORT COST

7. BIBS

Bibs for official training and the ski jumping competitions will be distributed one hour before the competition in the Race Office in the Ski Jumping Hill.

8. WAXING FACILITIES

You will find waxing cabins close to the Ski Jumping Hill - according to FIS rules.

Key pic up : In the elevator building in the Ski Jumping hill in the outrun. A deposit of Euro50 must be paid to recieve the cabin key.

The wax cabins will be available from Friday 12/09 from 08:00-16:00.

9. COMPETITION RULES

The number of participants in the competitions for Continental Cup SJ must comply with official FIS competition rules and regulations.

10.DOPING CONTROL

Doping control may be carried out at any FIS competition according to FIS Anti-Doping Rules.

11.ECONOMY - INSURANCE

Financial conditions are according to the FIS Rules and regulations.

All competitors must be insured by their own National Ski Association and must have signed the Athletes Declaration.

The Organisers have coverage for their own third party liability only.

12.VISA REGULATIONS

Remember that citizens of some countries will need visa for visiting Norway. Please check with your embassy if you need a visa to enter into Norway. For an official letter of Invitation, please send a request to the OC: <u>roar.olsen@olympiaparken.no</u>

13.Covid 19

Norwegian governments have come with new regulations for international travelling based on the fast development of the Covid19 situation in Europe. The government now recommends no travelling in or out of Norway. Anyone arriving in Norway from abroad shall be in quarantine for 10 days, with the exception of specified countries in Europe with sufficiently low transmission (less than 150 of 100.000 persons over two weeks). The only exceptions based on a very strict testing system will be athletes competing in the World Cup in Lillehammer. Based on this system all relevant countries for the COC cup will be effected with the exceptions of Finland.

We have the last days been working with our government to try to find solutions for an exception for our sport, without success for COC level. This means that everybody entering Norway from a red country must complete 10 days of quarantine, before being able to ski/train in Norway. This rule is for the moment implemented until the beginning of December and we think this will also be the case for a longer period. For the participant in the FIS world cup in Lillehammer 4-6. December, we are working on a solution without quarantine.
