- Distribution of start numbers (bibs) is in the tent on the start, without entering the tent, and wearing face masks and respecting 2m social distancing,
- Only one course inspection per race in bibs order with face mask
- due FIS COVID -19 regulations in the finish there are no results monitors (only current timing display)
- disinfect your hands befor distribution of bibs, etc..
- To pick up the bib it is mandatory to submit the form (Annex 1).
- The use of the face mask (min. KN95 or FPP2- OC request) is required in the hotel, indoor and outdoor, for example, course inspection, at the start, finish area and at the chairlifts, if there is no social distance less than 2,0 m.

General competition rules

The competition is organised according to the ICR and FIS Masters Rules Alpine Skiing.

Eligibility of competitors

Participation is limited to male and female skiers who are members of their National Ski Associations, age group 1990 and older. Each National Ski Association bears the responsibility that their entered competitors have signed the FIS Athletes' Declaration and are licensed to compete internationally. Athletes and coaches are responsible for their own insurance.

Enrolment fee and lift passes

Enrolment fee: 150,00 HRK (20€ per person per competition)

Lift passes: 70,00 HRK (10€ per person per competition – valid only for the race)

Entries

The entries (using the official FIS Entry Forms, including the year of birth, FIS Masters Code Numbers and current points) must be sent by a National Ski Association.

Liability

The organisers point out the compulsory insurance, they will not take any liability for participants, officials and spectators. If case the COVID-19 measures change at the »last minute«, the organizer allowes himself to cancel the competition without liability and reimbursement of the expenses.

If the number of participants is insufficient, the organizer allows himself to cancel the competitions (last day for canceling is January, 22th, 2021), without liability and reimbursement of the expenses.

CROATIA COVID 19. INFORMATIONS

The OC and competitors will respect all the security rules announneed by the FIS and Croatian Institute of public health to avoid any risk.:

On 13th of January 2021, the Civil Protection Headquarters of the Republic of Croatia issued a Decision **temporarily prohibiting and restricting the crossing of persons across all border crossing points of the Republic of Croatia** (NN 3/21). However, in accordance with the guidelines of the competent authorities, exceptions have been made as follows:

Passengers travelling to the Republic of Croatia from an EU / EEA member state (regardless of their citizenship)

Passengers coming directly from the countries and / or regions of the European Union, i.e. countries and / or regions which are Member States of the Schengen Area and Schengen Associated Countries, and which are currently in the so-called green list of the European Centre for Disease Prevention and Control, regardless of their citizenship, will be allowed entry into the Republic of Croatia under the same conditions as before the onset of the COVID-19 disease (they do not need to present a negative PCR test result for SARS-CoV-2 nor are they assigned the measure of self-isolation) if they show no signs of disease and they have not been in close contact with an infected person.

If the aforementioned persons **transited** to the border crossing points of the Republic of Croatia through other countries / regions without delay, they should **prove** at the border crossing point **that they did not stay** in transit areas and in that case, they will not be required to have a negative PCR test result for SARS-CoV-2 not older than 48 hours, nor stay in self-isolation.

Graphic representation of countries by color according to the risk of the COVID-19 disease can be found on the website of the <u>European Centre for Disease Prevention and Control (ECDC)</u>

All other passengers who, regardless of their citizenship, come to the Republic of Croatia from EU / EEA member states / regions, and which are currently not on the so-called green list of the European Centre for Disease Prevention and Control, must present a negative PCR test result for SARS-CoV-2 that is not older than 48 hours (counting from the time of taking the swab to arriving at the border crossing point) or have the PCR test for SARS-CoV-2 done immediately upon arrival in the Republic of Croatia (at their own expense), with the obligation of self-isolation until they receive a negative test result. In the case of impossibility of testing, a measure of self-isolation is determined for a period of ten (10) days.

Exceptionally, the PCR test for SARS-CoV-2 is not obligatory for the following categories of passengers traveling from EU / EEA member states / regions although they come from countries that do not belong to the green list of the European Center for Disease Control and Prevention:













- workers or self-employed persons performing essential tasks, including healthcare workers, frontier and posted workers and seasonal workers as specified in the Guidelines concerning the exercise of the free movement of workers during COVID-19 outbreak, provided they do not stay in the Republic of Croatia or outside the Republic of Croatia for longer than 12 hours;
- pupils, students and interns who travel abroad every day, provided that they do not stay in the Republic of Croatia or outside the Republic of Croatia for longer than 12 hours;
- seafarers and workers in the transport sector or transport service providers, including heavy goods vehicle drivers transporting goods to be used in the national territory and those who only transit;
- diplomats, staff of international organizations and persons invited by international organizations whose physical presence is necessary for the functioning of those organizations, military personnel and police officers, as well as humanitarian and civil protection personnel in the performance of their duties;
- persons traveling for necessary family or business reasons, including journalists in the performance of their duties:
- passengers in transit with the obligation to leave the Republic of Croatia within 12 hours
- patients traveling for urgent health reasons.

The provisions regarding frontier workers apply adequately to other categories of passengers who, due to the nature of their job or occupation, need to cross the state border frequently (e.g. athletes playing for clubs in a neighboring country).

Citizens of EU / EEA member states as well as members of their families traveling to the Republic of Croatia from third countries, i.e. those that are not members of the EU / EEA

Citizens of EU Member States (including Croatian citizens), i.e. of Schengen Member States and Schengen Associated States, as well as members of their families and third-country nationals who are long-term residents under Council Directive 2003/109/EC of 25 November 2003 concerning the status of third-country nationals who are long-term residents and persons entitled to reside under other EU directives or national law or who have national long-term visas coming from third countries, upon entering the Republic of Croatia must present a negative PCR test result for SARS-CoV-2 that is not older than 48 hours regardless of their citizenship (counting from the time of taking the swab to arriving at the border crossing point) or have the PCR test for SARS-CoV-2 done immediately upon arrival in the Republic of Croatia (at their own expense), with the obligation of self-isolation until they receive a negative test result. In the case of impossibility of testing, a measure of self-isolation is determined for a period of ten (10) days.















Exceptionally, for the abovementioned persons, a negative PCR test result for SARS-CoV-2 not older than 48 hours will not be obligatory at the border crossing point for healthcare workers, health researchers and caregivers for the elderly, frontier workers, workers in the transport sector, diplomats, staff of international organizations and persons invited by international organizations whose physical presence is necessary for the good functioning of those organizations, military personnel and police officers, as well as humanitarian and civil protection personnel in the performance of their duties, passengers in transit with the obligation to leave the Republic of Croatia within 12 hours from entry and persons travelling for schooling purposes, as well as persons who travel for urgent personal / family reasons, business reasons or have some other economic interest, and do not stay in the Republic of Croatia for more than 12 hours.

Third-country nationals not covered by the abovementioned points

Third-country nationals not covered by the abovementioned points may enter the Republic of Croatia from third countries, and on that occasion, they do not need to present a negative PCR test result nor a self-isolation measure will be assigned to them, only if they are:

- 1. healthcare workers, health researchers and caregivers for the elderly;
- 2. frontier workers (as well as e.g. athletes as stated in the exceptions for passengers within the EU / EEA);
- 3. workers in the transport sector;
- 4. diplomats, staff of international organizations and persons invited by international organizations whose physical presence is necessary for the good functioning of those organizations, military personnel and police officers, as well as humanitarian and civil protection personnel in the performance of their duties;
- 5. passengers in transit with the obligation to leave the Republic of Croatia within 12 hours from entry;
- 6. persons travelling for schooling purposes;
- 7. seafarers (if they intend to stay in the Republic of Croatia for more than 12 hours, entry into the Republic of Croatia will be provided upon presentation of a negative PCR test on SARS-CoV-2 not older than 48 hours or by PCR testing on SARS-CoV-2 immediately upon arriving to the Republic of Croatia and by self-isolating until they receive a negative test result);
- 8. persons travelling for urgent personal / family reasons, business reasons or other economic interest (if they intend to stay in the Republic of Croatia for more than 12 hours, entry into the Republic of Croatia will be provided upon presentation of a negative PCR test on SARS-CoV-2 not older than 48 hours or by PCR testing on SARS-CoV-2 immediately upon arriving to the Republic of Croatia and by self-isolating until they receive a negative test result).













Passengers covered by Annex I to Council Recommendation (EU) 2020/912 on the temporary restriction on non-essential travel into the EU and the possible lifting of such restriction

Passengers (regardless of their citizenship) coming directly from countries currently covered by Annex I to Council Recommendation (EU) 2020/912 on the temporary restriction on nonessential travel into the EU and the possible lifting of such restriction, namely Australia, Japan, New Zealand, Rwanda, Singapore, South Korea, Thailand, Uruguay, China and special administrative regions of the People's Republic of China - Hong Kong and Macao, do not have to present a negative test result for SARS-CoV-2 nor are they subject to self-isolation if they have not been in close contact with an infected person and show no signs of disease. During their stay in the Republic of Croatia, they are obliged to adhere to the general and special recommendations and instructions of the Croatian Institute of Public Health.

At the border crossing point, the aforementioned persons, who transited to the border crossing points of the Republic of Croatia through other countries / regions without delay, should prove that they did not stay in transit areas and in that case, they will not be required to have a negative PCR test result for SARS-CoV-2 not older than 48 hours nor stay in self-isolation.

In order to shorten the procedure at the border crossing point, we advise all foreign passengers, regardless of their citizenship, to fill the announcement in advance at Enter Croatia.

General note: if the passenger's validity of the PCR test for SARS-CoV-2 of 48 hours expired during the border control at the entrance to the Republic of Croatia or they do not have the PCR test at all and they meet other conditions of entry, they will be allowed to enter the Republic of Croatia, provided that they immediately get tested in the Republic of Croatia at their own expense, with the obligation to stay in self-isolation until they receive a negative test result.

Lifting the measure of self-isolation (imposed on the border crossing point) after the receipt of a negative PCR test result:

In such cases, passengers will receive a leaflet at the border crossing point with instructions on the actions to be taken after they receive a negative molecular PCR test result (rapid antigen tests or serological tests will not be accepted).

The leaflet will include an e-mail address of the border crossing point where the passenger was imposed the measure of self-isolation, to which he/she can send the negative test result obtained from the medical facility where the test was taken, so that the imposed measure can be lifted (removed).

These persons are obligated to take the test at the place of their temporary or permanent













residence, where they have all of the necessary conditions for self-isolation until their negative PCR test result arrives.

Persons who have recovered from COVID-19 within the past three months are exempt from the obligation to provide a negative PCR test result and to self-isolate.

In order to prove their recovery, passengers need to have a positive PCR test result or antigen test result, or a positive neutralization test (NT) result obtained within the last three months and older than 14 days, or a certificate of recovery issued by a doctor.

Persons who have a negative PCR test result made in the Republic of Croatia due to a short trip to our neighboring or another country and return to the Republic of Croatia within less than 48 hours from the day of testing, i.e. within the period of test validity, will not be required to present a new PCR test from the country in which they have been staying for a short time, but will be allowed to enter upon presenting the test made in the Republic of Croatia.

When staying in the Republic of Croatia, all passengers, regardless of their category and country from which they came, are obliged to follow the general and special instructions and recommendations of the Croatian Institute of Public Health.

For all foreign passengers, regardless of citizenship, due to the shortening of the procedure at the border crossing, we advise you to fill in the announcement in advance via the Enter Croatia application https://entercroatia.mup.hr/















The use of the face mask is required in the hotel, indoor and outdoor, for example, at the start, finish area and at the chairlifts, if there is no social distance less than 2,0 m.

- Hotels are opened only for hotel quests, so, our reccomendation is to take full or half board in the hotel because bars and restaurants in Croatia are closed. It is only possible to order take away in some restaurants, or drive ins. Also, distribution by Bolt, Wolt etc is possible.

On the top of hill there are no opened restaurants, and take away might not be possible, too. Shops of all kinds are opened, although, there are some changes in the working hours.

- if you feel sick, stay at home,

In Zagreb (8 km away from the city center) we had the earthquake (5,5 Richter) last March, and December 29th, 2020, 50 km from Zagreb in Petrinja (6,4 Richter=, too . Becauce of that, some of the old buildings in the city centre are still damaged. Please, take care during the sightseeing, because some afterschocks are possible.









COVID-19 PROTOCOL FOR FIS EVENTS INTRODUCTION

- This Protocol applies to FIS competitions including FIS, NC, NJR, UNI, CIT, CITWC, MAS, OPA, JUN, CHI competitions in Croatia for FIS disciplines (except WC events that are ruled by the FIS specific protocol).
- It supplements and does not replace the national and regional regulations for:
 a. use of lifts or other means of transport.
- b. access to the competition venues.
- c. use of hotel or restaurant services.
- d. social distancing.
- e. collective hygiene standards and use of personal protective equipment.

COMPETITION COURSE (Race track and adjacent areas, start and arrival area) • Must have a delimited access with an individual entrance to the track and one or more dedicated and marked exit routes. • Only accredited competitors, technicians, judges, and other competition officials, rescue and technical support staff are allowed. • No spectators are allowed. • The presence of possible spectators outside it is ruled by the regional and national regulations.

ACCESS TO THE COMPETITION COURSE

It is mandatory to wear the race bib

PUBLIC PICK/PUBLIC DRAW

- To pick up the bib it is mandatory to submit the form (Annex 1).
- For non-disposable bibs, sanitation is necessary after each use.
- Bibs must be delivered to the team leader:
- > no contact with the athletes by other personnel;
- if necessary, put the bibs on a bib holder where athletes can pick up them.
- No public draw ceremony.

START AREA

- A departure area large enough to guarantee the required distance must be defined.
- Everyone allowed in the area must wear the mask.
- Athletes can only remove the mask within the starting area 5 minutes before their starting time.
- only one accompanying person per competitor is allowed.
- Make sure that the way out for the guests does not interfere with the competitors waiting to start.
- In order to avoid gathering, please respect the starting time of the competitors.

TEAM HOSPITALITY (IF ALLOWED)

- Review the space to respect the appropriate distances.
- Reduce the number of volunteers in this area to the minimum necessary.
- It is forbidden to organize buffets.
- Provide food in single portions.
- Provide sufficient quantity of water in single bottles.















- Provide drinks in single bottles.
- Limit interaction/connection between volunteers and team members.
- Clean and sanitize regularly and exchange air when teams are not present.
- Reduce the number of volunteers in the area where the distance is limited.

ARRIVAL AREA

- Everyone allowed in the area must wear the mask. Athletes must wear the mask if they stay longer than necessary.
- it is forbidden to organize buffets.
- Provide sufficient quantity of drink in single bottles.
- No "change tent" on arrival.
- The athletes must leave the common area as soon as possible.
- Please make sure that the transport of the athlete's equipment from the start area to the arrival area is provided only by the team personnel.
- Have the athletes put bibs and chips in plastic containers at the end of the race.

AWARD CEREMONIES

■ No public award ceremony

JURY MEETINGS

• One club/regional committee representative is allowed to attend the jury meeting. If spaces are not appropriate these meetings must be held online.

FURTHER PROVISIONS

- Everyone involved in the organization must wear personal protective equipment (approved masks).
- Athletes, Technicians and staff must wear personal protective equipment (approved mask)
