- ❖ Protocols take into consideration recommendations made by the International Ski Federation (FIS).

“RACE” BUBBLE TESTING PROTOCOL

Ski teams + Ski team staff + FIS staff

To get accredited, you need to:

1. Present the results:

- ❖ Of a negative nasal RT-PCR test performed no later than 72 h prior to the declared arrival on site by the team captain or racers. Possibility to add 24h to this duration if the test has to be done on a Sunday or public holiday.
- ❖ Or of an “Abott or Roche” serology test >0 less than 8 weeks old

2. Fill out the Contact sheet (annex n°1) and the FIS questionnaire (annex n°3).

It is obligatory to give to the organizers the FIS questionnaire for each racer and each staff member to the organizers during the accreditation process.

On the arrival at the event

In case of any doubts or symptoms: contact the Doctor designated by the organizers and make an antigen test.

After the races

Contact the Doctor designated by the organizers for any typical symptom.

The Organizing Committee recommends that you:

- Download the “tous anti-covid” (all against covid) application
- Get a flu vaccination shot
- Fill out the FIS questionnaire before each test

- 2. Fill out the FIS questionnaire**

PROTOCOLS TO FOLLOW FOR: CASES WITH SYMPTOMS / POSITIVE CASES/ CONTACT CASES

Suspicion:

Someone showing typical symptoms:

→ Inform the designated Doctor

1. Immediately isolate /quarantine the person in the room designated for this purpose: conduct an RT-PCR test and a remote medical consult.
2. If the RT-PCR test is negative → returning to the event is possible after a remote medical consult.
3. If the RT-PCR test is positive → quarantine + medical consultation with the Doctor designated by the organizers.

Contact cases:

Identified by ARS and/or COVID-19 unit

Immediately isolate the person and medical exam with the Doctor designated by the organizers.
