Measures in this document are to be considered subject to change and will be updated regularly as the epidemic situation in Italy - Veneto Region and Province of Belluno evolve.

This document complies with the National and Regional rules valid on the date highlighted at the end of this protocol and the registration for the event includes its full contents and acceptance by each person who will participate in the event.

The organizer reserves the right to make necessary changes, which will be announced immediately.

1. ACTUAL SITUATION IN ITALY

Currently and until December 3rd, the level of risk in Italy is divided by Regions and is updated in view of the epidemic trend and of the situation of health/hospital systems.

At the date of update of this document, the Veneto region, in which the town of Cortina d'Ampezzo is included, is in the "yellow area", the lowest-risk area, in which restrictions valid throughout the State's territory apply.

Other regions are included in the "orange areas" and "red areas", where more restrictive measures apply.

Actually, the most significant restrictive measures for yellow areas are:

- It is forbidden to circulate from 10pm to 5am, except for proven reasons of work, necessity and health. It is recommended not to move except for reasons of health, work or situations of necessity (in these cases you need a self-declaration to move - see Annex 1);
- Restaurants and bars close at 6pm. Take away is allowed until 10pm, no limitation for delivery;
- Limitations on public transport (maximum capacity of 50 % for buses, trams, metro and trains);
- Shopping centers stay closed on weekends and public holidays.

Please note that there are strong limitations in mobility to and from regions with higher restrictions.

In the entire territory of the State, skiing is allowed only for professional athletes' training and only 3 resorts are open on the south side of the Alps at the moment.



2. GENERAL

All those taking part in the event are required by LOC to **present a negative PCR test** (see below).

The most important prevention measures are:

-use of face masks (it's strongly recommended a Fpp2 or Fpp3 mask. Those with valves are forbidden!),

-keeping distance (at least 1,5 mt, 2 mt when doing sports activity),

-avoiding create gatherings and frequent hand hygiene.

In any case **it is the responsibility of every person to** adhere to the policy, follow all procedures and instructions and **behave in a disciplined manner at all times.**

In particular and in order to minimise the risk of infection, the LOC strongly recommends the teams:

- Remain in small groups.
- Avoid contact with other teams.
- Avoid contact with LOC staff.
- Avoid contact with tourists/fans.
- Interviews with journalists only with socially accepted distance and mouth and nose protection (as below).
- Wash and disinfect your hands regularly.
- Documentation of your current health status.

3. INFORMATION ABOUT TEST

All those taking part in the event are required by LOC to **have a negative RT-PCR test not older than at 72 hours** (this means **maximum 72h between taking the sample and collecting the accreditation**).

For the test protocols we need at least one contact person (team captain or team doctor) including contact details (name, mobile number, e-mail address) - please announce this at the FIS Online Entry.

The testing certificate must be issued by laboratories accredited by the National Ministry of Health in the Country where the test is carried out!

The certificate must indicate the **accreditation/authorization details of the laboratory, Name, Surname, date and place of birth of the person tested and the date and time of sample collection.**

PCR tests are preferred before arrival. Should there be any problems with external PCR tests, the LOC is arranging some solutions nearby Cortina, but please consider that, due to the actual emergency situation, you could wait up to 72 hours to get the result of the test.

Event if at the moment this is not necessary, please take note that the Local Health Authorities, due to the evolution of the pandemic emergency, could ask a re-test during your staying in Cortina. All costs for testing shall be borne by the person or company.

Should the test be positive: DO NOT travel to Cortina d'Ampezzo!

Only the following situations will be submitted to a medical evaluation from the LOC:

- A. if you're able to submit a valid positive PCR test result non earlier that 21 days before the second result, call the Covid-19 management line (see above) for an evaluation before your arrival in Cortina d'Ampezzo;
- B. if a member of the team should be tested positive, he must not travel to Cortina, call immediately the the Covid-19 management line (see above) to evaluate if there are the conditions for the team to take part in the event undergoing a strict surveillance regime with daily PCR test.

4. REGISTRATION

People involved in the event will be divided in the following groups:

GROUP RED No. 1 and 5 on the accreditation card):

Athletes, coaches, support, service, SRS, FIS, Timing & Data, DCO;
LOC responsables and employees: closest management, race office, start, finish, medical and rescue service, public order and security, DC chaperone.

GROUP YELLOW (No. 2 and 3 on the accreditation card):

Media, Host Broadcaster, Infront, other TV and radio stations, journalists, photographers.

GROUP BLU (No. 4 on the accreditation card):

LOC staff and production along the race field, from start to finish areas, external suppliers.

Accreditation procedure for RED and YELLOW groups (with the exception of LOC personnel) goes through the next steps:

- Step 1: registration of PCR Covid-19 test and upload the result, recording of whereabouts and health questionnaire completion in the FIS Passport;
- Step 2: all data will be automatically imported from FIS Passport to the event's accreditation programme. The Covid-19 coordinator checks each registration and gives the authorization to issue the accreditation. Should be any problem, the person will be contacted immediately by the Covid-19 coordinator to decide to decide what actions to take;
- Step 3: passed the previous steps, the person receives an e-mail notification that accreditation card can be withdrawn.

LOC's personnel in the RED and BLU groups need to undergo an antigen test before picking up the accreditation.

5. TRAVEL TO CORTINA D'AMPEZZO

In case of COVID-19 symptoms or positive PCR test DO NOT travel to Cortina d'Ampezzo.

We strongly recommended to use your own vehicles to reach Cortina d'Ampezzo, avoiding intermediate stop. If you're arriving by plane, Venice Airport as first destination in Italy is suggested, so that you avoid travelling through other Regions where there are severe restrictions on mobility.

Avoid contact with other people - especially outside the team.

Wearing face mask is mandatory when you're travelling both with your private vehicles and with public means.

There is no limitation for people entering Italy to take part in international sports events. In any case if you come from some Countries identified as risky by the Italian Ministry of Health or transit through those Countries in the 14 days prior to entering Italy, you may be asked to:

-fill in a self-declaration (see attached), stating the reason for entry (see annex 2);

-present a statement that you have undergone a molecular or antigenic test (however antigenic test is actually not accepted by the LOC) carried out by means of a swab and a negative result within 72 hours before entering the national territory;

-for those coming from Nations included in E and F list, it's necessary to obtain exemption from quarantine for the reason you are participating in international sports events, from Office 3 of the General Directorate of Health Prevention (USMAF-SASN Coordination). The request can be submitted through the LOC, not early than December 4th.

6. PICKING UP ACCREDITATION

Access to the accreditation and race office is allowed only to one representative per Nation.

Please note that for safety reasons the LOC privileges low or no-touch payment where possible, so that credit cards payments should be the rule.

7. TEAM CAPTAINS' MEETING

Use of virtual technology should be preferred for the Teams Captains' Meetings OR, in case of physical TMC, only one representative per Nation is admitted, plus those strictly necessary from FIS officials, Timing and LOC representatives.

8. HOTEL ACCOMMODATION

The accommodation facilities in Cortina d'Ampezzo are already set up to host athletes and teams, according to the guidelines of the Veneto Region and the FIS. Dedicated meals areas and/or dedicated shifts for meals will be arranged.

The use of face masks is mandatory throughout the hotel, except for the time of consuming meals seated at the table and when you're staying in your own room. We strongly recommend avoiding the use of lifts and staying the less time as possible in the public areas.

9. ACCESSING AND MOVING IN THE VENUE (LIFTS, SLOPES, FACILITIES)

People with a temperature over 37.5°C are not allowed to enter the venue.

The access to the venue is allowed only wearing face masks, with the exceptions as in the above chapters.

Since the National guidelines for lifts and ski resorts are still not available at the moment, we cannot know if the ski area will be opened also to tourists for skiing. This is the main reason why we cannot indicate the way to up and the specific rules for the access to the hospitality refuge.

You'll find more information in the next updates, also by email, or at your arrival to Cortina.

10. RACE AREA

Access to the competition area must be reduced to the fewest number of people possible.

All persons involved in the event (athletes-teams-SRS, officials and members of the National Association, LOC personnel staff and volunteers) must wear a face mask in all the venue.

Exemptions from the use of masks:

-the athlete during warm-up (in these cases they must keep a minimum distance of 2 mt);

-the athletes during race: approaching the start line, they will be able to remove the mask, keep it in their own clothing or throw it in a special bin; once they reach the finish area, exiting the parterre they must wear the mask again.

The access to and exit routes from the competition area will be organized as to avoid intersections between athletes and their teams and all the rest of the staff.

In any case, no LOC staff members and volunteers are allowed to approach the athletes for any reason, with the exception of medical services personnel.

Access and exit gates from the competition area will be provided with disinfectant hand gel.

11. SKI-LIFT DEDICATED TO THE RACE

There will be prepared two separate lines to access the ski-lift dedicated to the race, one for athletes and teams and one for the other users.

All those accessing the lift must wear face mask and gloves.

If possible (depending on snow conditions), two release points will also be created uphill so to avoid that athletes and teams, and all the other involved in the event can cross.

No tourists are admitted on this lift!

12. TIMING

Timing personnel at start must wear face mask and it's not allowed to have any physical contact with athletes.

In the finish area is located the timing cabin (approx. 15 sqm), equipped with windows to guarantee air circulation. This structure, as well as the TV production space, is provided with an innovative catalytic film eliminates up to 99,99% of viruses and bacteria and has been successfully tested against Sars-Cov-2. Nevertheless personnel working in this space must wear a Ffp2 mask all the time.

13. MEDIA & BROADCASTERS

All accredited media, including photographers and cameramen, must always wear a mask when they are inside the venue (IBC, TV compound, mixed zone, photographers' platforms, coaches' platforms, start area, photo positions on the slope and so on).

LOC recommends limiting as much as possible any interviews with athletes before or after the event, and/or any direct contact with other accredited people.

A sanitized space, with an independent entrance from the outside, located on the ground floor of the Faloria refuge, will be available for the TV production. This space also is provided with the catalytic film mentioned above.

The LOC cannot have control inside TV production area and TV production truck in Rio Gere.

This means that each company is responsible for indoor spaces hygiene management. Use of face masks is mandatory during all the time people are working inside. It is strongly recommended not to introduce to these spaces people unrelated to TV production.

14. MIXED ZONE

Tv / Radio / Media will be admitted in the mixed zone at social distance of at least 1,5 mt. and wearing a face mask.

- ⇒ Involve as few people as possible.
- ⇒ 1,5 mt. distance to athlete.
- ⇒ No cell/smart/mobile phones or similar, only proper microphones. Microphones should be wiped with approved disinfectant wipes before and after use. Remove any windscreens (microphone covers) from the microphone boom to allow the surface to be wiped down completely. Disinfected microphones and other technical gear should be placed in sanitised storage boxes to prevent contamination before their next use. Microphone windscreens need to be changed regularly.

15. BIBS MANAGEMENT

There will be no bib draw public ceremony. The LOC will manage the most secure solution for bibs delivery. All bibs will be sanitized and packed in a sealed envelope until the moment of their distribution. It is the responsibility of each athlete to take off the bib and deposit it in special bags at the exit of the finish area.

16. AWARD CEREMONY

It'll take place in the finish area. Any contact between athletes/teams/officers/authorities and so on, is not allowed. Each prize, sanitized, will be placed at the athlete's feet who will collect it independently. Any gathering is absolutely forbidden. Shake hands, hug, etc. with the other athletes on the podium are not allowed and elbow bumping, nodding, bowing etc. are not recommended. FIS Covid-19 Ceremony Guidelines will be apply.

17. DOPING CONTROL

Chaperones must wear a FFP2 facial mask. They must keep a distance of at least 1m from the athletes and check that they are wearing a face mask as well. Chaperones will accompany the athletes to the doping station where only the responsible for chaperones is allowed to stay (the others must wait out of these spaces until the end of sample collection). The sample collection will follow hygiene rules by FIS.

18. COVID-19 SUSPECT CASE MANAGEMENT

Any problem or discomfort during the event must be immediately reported to the COVID-19 Manager appointed by the LOC, to activate the chain of rescue. The Prevention Authority will be soon notified, for the activation of the national COVID-19 protocols which are under its responsibility.

A quarantine protocol will be immediately activated. The person must immediately go into isolation in his hotel room or his quarters. The person's close contacts will be put in quarantine too (see annex 3 to see the definition of "close contact" and the duration of quarantine).

If a person tests positive to COVID-19, all actions needed will be discussed and decided between LOC, Health Authority and FIS Officials.

Regarding the external communication, this person must strictly follow the communication procedure described by FIS.

A dedicated COVID-19 ambulance can be immediately activated in case of need.

Please note that since the costs of quarantine / isolation, testing, etc. should be carried by the infected person, we suggest that you check that they are covered by your health insurance.

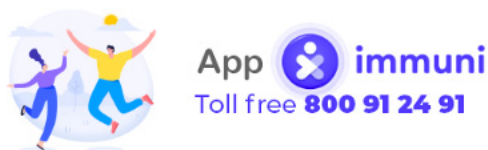
19. HEALTH QUESTIONNAIRE

Each team member must fill in the health questionnaire prescribed by the FIS and bring it to the event shortly before arrival (see annex 4).

Before the competition (qualification), a self-declaration must be submitted to the LOC by each team, in which the state of health of the individual team members is documented (see annex 5).

20. CONTACT TRACING APP

It is hardly recommended to each one taking part in the event to download in its mobile phone the APP "IMMUNI". "Immuni" is an app that helps us fight the COVID-19 epidemic. The app uses technology to alert the users who have had a risky exposure, even if they are asymptomatic. Available in ITA- ENG - DEU - FRA - ESP - both in Apple and Google store.

DEFINITION OF **CLOSE CONTACT**

"Contact" is to be understood as "**close contact**" with a probable or confirmed case, as defined by the [Circular of the Ministry of Health of March 9, 2020](#), namely:

- a person living in the same house as a COVID-19 case, which is the same as sharing the same room;
- a person who has had direct physical contact with a COVID-19 case (e.g. handshake);
- a person who has had unprotected direct contact with the secretions of a case of COVID-19 (e.g. touching used paper tissues with bare hands);
- a person who has had direct (face-to-face) contact with a case of COVID-19, at less than 2 meters and lasting longer than 15 minutes;
- a person who has been in an enclosed environment (e.g. classroom, meeting room, hospital waiting room) with a case of COVID-19 in the absence of suitable PPE;
- a person who has travelled seated on an aircraft in the two adjacent seats, in any direction, of a COVID-19 case, as well as his or her travelling companions or caregivers and crew members sitting in the section of the aircraft where the index case was seated.

INDICATIONS FOR THE DURATION AND TERMINATION OF **ISOLATION AND QUARANTINE**

(Source: Circular of the Ministry of Health of 12 October 2020)

Asymptomatic positive cases

Asymptomatic people who have been tested positive for SARS-CoV-2 may return to the community after a period of isolation of at least 10 days after the onset of positivity, at the end of which a molecular test with negative result (**10 days + negative PCR test**) is performed.

Symptomatic positive cases

Symptomatic people who have been tested positive for SARS-CoV-2 may return to the community after a period of isolation of at least 10 days after the onset of symptoms (not considering anosmia and ageusia/dysgeusia that may have prolonged persistence over time) accompanied by a molecular test with negative feedback performed after at least 3 days without symptoms (**10 days, at least 3 of which without symptoms + negative PCR test**).

Long-term positive cases

People who continue to be positive for the SARS-CoV-2 molecular test, in case of no symptoms (except for ageusia/dysgeusia and anosmia that may last for a long time after recovery) for at least one week, they **may stop isolation 21 days after the onset of symptoms**. This criterion may be modulated by the health authorities in agreement with clinical experts and microbiologists/virologists, taking into account the immune status of the persons concerned (in immunodepressed patients the contagious period may be prolonged).

Asymptomatic CLOSE CONTACTS

Close contacts of SARS-CoV-2 infected cases confirmed and identified by the health authorities shall observe:

- a quarantine period of 14 days from the last exposure to the case,
or
- a quarantine period of 10 days after the last exposure with a negative antigenic or molecular test carried out on the tenth day.
