

Hygiene protocol FIS European Cup

For the "Junior FIS Snowboard" event from February 20th – 23rd, 2021 at the Göttschen ski lifts in Bischofswiesen by Snowboard Germany due to the legal regulations when carrying out an event. Operators and organizers communicate the need to comply with the safety measures. An adaptation of the [general hygiene concept](#) from Snowboard Germany. In addition, the hygiene and distance rules of the mountain resort must be observed.

I. As in private, also in sport:

1. Comply with distance rules or mask requirement if the distance rule cannot be adhered to,
2. Compliance with the cough / sneeze etiquette (sneezing and coughing in the elbows),
3. Regular hand washing and hand disinfection,
4. Shared sports equipment (snowboards) are regularly disinfected
5. Athletes are provided with sufficient washing facilities, liquid soap and disposable towels. The participants are informed about regular hand hygiene by notices.

II. FFP2 Mask requirement

FFP2 mask requirements apply on the entire event site. Buffs or similar mouth and nose coverings are not sufficient and are not permitted.

III. Athletes/Referees/Coaches

Trainers and supervisors must, if possible, always keep a distance of at least 1.5 meters from the athletes. The transfer of material takes place without contact through a defined pick-up and pick-up area. The minimum distance to the judges must be strictly observed. Shaking

hands, clapping, hugging must be completely avoided in accordance with the distance regulations. All athletes are advised of compliance with "no contact"

IV. Bibs

The start numbers are picked up by the trainers, the athletes keep them during the entire event. The handover of the starting numbers to the trainers is contactless. The start numbers will only be issued upon submission of the forms filled in by the athletes [Unbedenklichkeitserklärung](#) (siehe Anhang).

Giving out Bibs

The distance of 1.5 meters must be strictly observed when issuing. Disposable towels, disinfectants and masks are provided.

V. Prize Giving

The award ceremonies are carried out quickly and in compliance with the general rules of distance and hygiene. Interviews and large gatherings of people (group photos) are forbidden.

VI. Spectators

No spectators are allowed

VII. Not allowed to participate in the event:

1. People who have been in contact with COVID-19 cases in the past 14 days.
2. People with unspecific general symptoms and respiratory symptoms of any severity
3. Persons without negative Covid 19 test (max 72h)
