

COVID-19 Prevention Guidelines and Recommendations for teams for the AUDI FIS Ski World Cup Altenmarkt/Zauchensee 2022 Update from 6th January 2022

Due to the COVID-19 pandemic, the **AUDI FIS Ski World Cup Zauchensee organized on 15th and 16th January 2022** must take place under tight security measures due to the continuing COVID-19 pandemic. Based on the current regulations published by the Austrian Federal Ministry of Health and further measures taken by FIS and the Austria Ski Veranstaaltungsgesellschaft GmbH, as the organizers of the event, we would like to present the following catalogue of measures to all teams published on 6th of January 2022. We kindly ask you to forward this information to all team members (athletes, coaches, staff, NSA officials etc.) and FIS officials/employees registering for the event via the FIS platform. By registering for this event, each team member and every FIS official/employee fully confirms and accepts the content of this catalogue of measures for the above-mentioned event.

Important information:

- Take responsibility for your own actions
- Follow hygiene measures (regularly wash your hands and disinfect)
- Show proof of negative PCR test not older than 48 hours
- Re-testing is necessary for all people without vaccination
- Contact data collection for each team for contact tracing
- Answer the health questionnaires
- Maintain at least 2 meter distance from others wherever you go
- Wear a FFP2 mask is mandatory in all venue areas
 - Exception during sports exercise
 - And while drinking and having a meal

As the organizers of the event, we are obliged to limit the number of accredited people due to the COVID-19 situation. Therefore, only team officials are granted access to team and sports relevant areas, in line with the respective FIS Entry system. People outside the applicable FIS Entry system are not allowed to enter the above-mentioned areas!

Entry regulations for Austria!!

People arriving from countries with low infection rates need a 2G+ verification (vaccinated or recovered with an additional PCR test). A third vaccination liberates from the necessary PCR test. Persons without PCR test or third vaccination do need to [register](#) and must go into quarantine till they can show a negative PCR test result.

Without a valid 2G verification (vaccinated or recovered), people are allowed to enter Austria, but they must go to quarantine immediately for 10 days. A test for leaving the quarantine is possible on the 5th day.

People from “virus variances countries” are only allowed to enter with a work-related reason. Those persons must show a negative test or an equal medical certificate and must do the [registration](#) before entering Austria.

Please be sure to check your home country’s travel regulations prior to your arrival in Austria.

Arrival in Altenmarkt/Zauchensee

- Do not arrive at the venue when showing COVID-19 symptoms.
- Avoid stops between your place of departure and the event location.
- Avoid contact with other people, especially outside your team.

COVID test checks/health questions/contact tracing

- Every team member officially named by the respective national ski association via the FIS online system and FIS officials/employees are obliged to present a **negative PCR test not older than 48 hours upon accreditation**. The PCR test presented needs to be recognized by the health authority of the respective country! For all PCR tests it is necessary to indicate the time of taking the sample and the name.
- **The corresponding test protocol needs to be uploaded to the FIS Passport platform at least 12 hours prior to collecting accreditation**. If you don't have the opportunity to take a PCR test prior to your arrival in Austria, you will find a list of laboratories offering PCR tests in Austria in Appendix 1 (please check for opening hours, evaluation times, costs, etc.). In case of inconclusive PCR test results, the LOC reserves the right to ask you to take a new test.
- Together with the test protocols and for possible contact tracing, you need to name at least one contact person (team captain or team doctor) including contact details (name, mobile phone number, email address) - please provide this information via the FIS Online Entry System.
- **Furthermore, it is necessary to fill in the health questionnaire via the FIS Passport prior to collecting the accreditation and then daily for the duration of the event.**
- **RE-TESTING:** Everyone who is not vaccinated must present every 48h a new negative PCR test and must upload it on the FIS Passport. Everyone is responsible for ensuring that the results are there for the LOC to check.
- **If no verification is provided, the accreditation will be blocked and entering the event area is no longer possible!**
- The **vaccination and recovery certificate** must also be uploaded to the FIS Passport!
- The re-testing is valid for: **PCR test 48h**
- **FOLLOWING VACCINATIONS ARE CURRENTLY VALID IN AUSTRIA:**
 - BioNtech/Pfizer (at least 2 shots, valid for 270 days)
 - AstraZeneca (at least 2 shots, valid for 270 days)
 - Moderna (at least 2 shots, valid for 270 days)
 - Janssen Pharmaceutica / Johnson & Johnson (at least 2 shots, valid for 270 days)
- **Return to competition after an infection**
 - Scenario 1 – 10 days after positive result and a negative PCR prior to the event permitted to participate in event
 - Scenario 2 – 10 days after positive result and a positive PCR prior to the event – no exemption possible, accreditation will not be given
 - Scenario 3 – 14 days after positive result and a positive PCR prior to the event – Exception will be granted if it can be proven that it is DELTA VOC. – EXEMPTION If it cannot be proven, then an exception cannot be granted as such, but depending on the omicron situation, an individual assessment of the entire C19 infection history and complete testing results – incl CT values if possible - can be requested for individual assessment.

Accreditation/race office

- Only after presentation, examination, and documentation of the above-mentioned documents (PCR test, health questionnaire, contact person) will the accreditations be handed over to the team captain or a person appointed in advance.
- Only the team captain or **one** representative of the team is allowed to collect all accreditations for the entire team.

Accommodation

- The LOC has reserved appropriate team accommodation according to the FIS Entry system.
- You are required to show a negative COVID test or proof of vaccination/past infection in all hotels and restaurants!
- Check-in for all team members via team captain.
- It is required to wear an FFP2 mask in all public areas.

Transport/walk from accommodation to venue

- All teams are accommodated in Zauchensee a few minutes' walk from the event-location. It is easy to walk from the accommodation to the event site. At the entrance of the "Weltcuparena" there is a designated, separated corridor (red group) to the finish area.
- There are approx. 80 parking spaces for the red group in the "Weltcuparena" (parking level C max. 2,20m height). Please use team buses or vehicles as means of transport if possible.
- Only use the parking spaces allocated and marked for teams (red parking). Only people accredited for the red zone are allowed in the vehicle upon admission to the parking area.

Venue

- **Austrian Health Regulations (besides the FIS Guidelines):**
You must have an up-to-date Covid-19 certificate on every day, meaning one of those two:
 - **Vaccination with one of the vaccines mentioned above**
 - **Valid PCR test (48h)**
- **Daily health check:** Prior to every training session and competition, every team member must fill in the health check via the FIS Passport. **This is mandatory for all team members!**
- Maintain the minimum distance of 2m!
- Only stay in allocated and marked zones for teams (red zone).
- The team zone (red zone) is locked and can only be accessed by respectively accredited persons.
- Avoid direct contact with other teams.
- Avoid direct contact with members of the press.
- On the event site, wearing a FFP2 mask is mandatory.
- Food and drinks will be provided in the team hospitality area.
- Please only sit with team members in the team hospitality area (avoid contact with other teams).

COVID-19 symptoms and communication

- In case of a team member not feeling well or showing COVID-19 symptoms, please inform the LOC immediately by calling the Single Point of Contact.
- This number can be reached 24 hours a day from the official day of arrival until the official day of departure.
- The LOC will employ measures set out to deal with suspected cases of COVID-19.

- There is an isolation room provided near the venue in case you show symptoms.
- Any communication related to COVID-19 has to be coordinated with the FIS and the LOC (see FIS COVID communication guidelines).
- **COVID-19 suspected case management:** If there is a suspected case of COVID-19, please contact the SPOC. There is a stand-by team on site organizing further procedures including isolation, testing and contacting the authorities (the district commission of St. Johann im Pongau). Appropriate rooms will be available if isolation is necessary. In case of a positive test result, the authorities will decide on possible quarantine of further people in the surroundings (e.g., team members). **Isolation is imposed exclusively by the responsible health authority.**

Leisure activities during your stay in Altenmarkt/Zauchensee

- During all leisure activities, please respect COVID-19 measures such as maintaining physical distance, 2G, wearing a face mask, hygiene and avoiding contact.
- Restrict your leisure activities to necessary purchases and tasks that cannot be postponed.
- Spend your free time only with members of your team or your small group.

To minimize the risk of infection, the LOC makes the following recommendations:

- Form small groups.
- Avoid contact with other teams.
- Avoid contact with staff members of the LOC.
- Avoid contact with tourists/fans.
- Wear a face mask and maintain the minimum distance between yourself and journalists during interviews.
- Regularly wash your hands and disinfect.
- Document your health and any changes to your health.

We ask EVERYONE, to TAKE RESPONSIBILITY and comply with all the measures and recommendations listed above! There will be stewards in place to check and enforce the COVID-19 guidelines. Please follow the instructions of the staff for your own safety and the safety of others.

In case of violation or non-compliance with the COVID-19 guidelines, we reserve the right to exclude you from the event and take legal action.

The measures were determined in accordance with the current regulations, last updated on 03rd of January 2022. The organizer reserves the right to make necessary changes, which may be imposed immediately.

NOTE: It is necessary to show a PCR test from a recognized laboratory for the event! Therefore, we would like to name the following tests & laboratories:

Testing in the region Altenmarkt/Zauchensee

- **COVID19 Test Center Flachau:** (approx. 15km from Zauchensee)

The **COVID19 Test Center Flachau** is available for testing for the World Cup Races Altenmarkt/Zauchensee. In the COVID19 test center Flachau, officially recognized PCR and antigen rapid tests can be handled during the Ski World Cup (daily during the day and in the evening - appointment arrangement desired).

Status 28.11.2021 – Prices subject to change without notice.

The special price for PCR testing is only valid for testing during the Ski World Cup (Flachau & Zauchensee).

PCR test - result within 24h

€45,00 special price for testing during the Ski World Cup

for persons with Austrian e-Card (SV number) according to current law free of charge

Antigen rapid test - result within 20 minutes

€25,00 special price for Skiweltcup

Persons with Austrian e-Card (SV number) according to current law free of charge
