Transport (World Cup Rules Art. 11)

Official airport : Oslo Lufthavn Gardermoen. The OC will arrange transportation between the airport and the hotels. 1 transport (from and to the airport) free of charge. Price for additional transport: 20 € per person one way (will be deducted from the reimbursement)

Reimbursement

Reimbursement (World Cup Rules Art. 10 and 13)

Waxing facilities

- Wax cabins: available from 1/3/2022 at 10:00
- Waxing trucks : teams arriving with trucks have to inform the OC according to FIS rules.
