Logistical information

Accommodation

Booking according to the FIS Rules via FIS Online registration system. The OC offers following accommodation (full board included) in Kranjska Gora: 4* Kompas Hotel, Ramada Hotel&Suits, Hotel Spik. Additional information about the accommodation will be given to the teams after receiving preliminary entry and accommodation request.

Accreditation

All information regarding the accreditations will be known at the start of December.

Transport

Official airport: Ljubljana (LJU). The organizing committee will arrange transportation between the airports and the hotels. 1 transport (from and to the airport) free of charge. Price for additional transport: 90 EUR for max 7 persons. Shuttle service information (hotel – venue): shuttle service will be provided for teams without their own transport.

Reimbursement

Accommodation costs: Teams will pay directly in their hotels (persons from the pay lists will be paid by OC directly). Over quota costs are to be paid by cash or credit card.

Carrying costs/Reimbursement: Expenses sheets will be received in financial office during the race weekend or by e-mail. Payments will be done by bank transfer.

Prize money

Remember to upload bank info using the FIS Athlete Registration module in the FIS member section.

The current Slovenian tax rate for non-resident athletes is 15%. The income tax will be deducted and paid directly to the Slovenian Tax Authority

Waxing facilities

Wax cabins: available from 17/01/2022 at 12:00. Waxing trucks: teams arriving with trucks must inform the OC before 10/12/2021. The keys of the cabins are available at the Race Office (at OC office before Wednesday 19/01/2022) and must be return to the same place on the day of departure. The deposit is 100 €/team

The event will be organized according to FIS Covid-10 Prevention Guidelines and Slovenian laws and requirements.
