COVID - 19 PROTOCOL FOR FIS COMPETITION HELD IN POLAND

- 1. GENERAL LOC and Polish Regulation
- # Use protection mask in all closed public areas and in the open space where you can't keep at least 1.5m distance from others
- # Clean hands and use hygienic liquids
- # Keep social distance min.1,5m
- 2. ARRIVAL TO POLAND

No quarantine after presenting the UE C-19 vaccination certificate or recovery certificate or negative C-19 result no older than 48h.

3. RESTRICTIONS IN MOVING AROUD

Face covering (mouth and nose) is mandatory in public areas like shops, petrol station, public transportation and hotel. No need of face covering (mouth and nose) in the open space or private car where the distance min.1.5m can be kept.

4. VENUE





Mandatory use of mask except for athletes when worm-up and during the start. When athlete is not using the mask the social distance need to be kept.

in situation where 1,5m distance can't be keep (waiting room at the start, coach platform)

Every person who wishes to access a venue must complete a Health Questionnaire (see Annex 1).

Protection mask need to be used all the time: no need only during warm up and start in the competition.

During the prize giving ceremony athletes need to wear a mask. Mask can be take out only for photoshoots when social distance is kept.
