***1. ENTRIES***

Entries will be accepted from National Ski Associations following FIS quotas and rules no later than **January 23<sup>rd</sup>, 2022**.

***2. VISAS***

Currently the citizens of Shengen countries, Switzerland, Belarus, Kazakhstan do not require to have a visa to visit Ukraine. Please, contact us in case of necessary arrangements.

***3. ACCOMMODATION and TRANSPORTATION***

Accommodation is provided at hotel Edelweiss (Sil village), 15 minutes from the resort. Costs are as follows:

Double room (half board + transfer to the hill) – **70 Eur per room** per day paid in cash.

Single accommodation (half board + transfer to the hill) – 50 Eur per person per day.

Transportation. Closest airport is Lviv (LWO) with 4 hours travel. Approximate costs for one way transportation: minivan up to 8 pax – 150 EUR, bus up to 15 pax – 210 EUR. #### **4. RACE OFFICE**

Race office will be located in the Alpen House Hotel (by the competition site, at top of the lower chairlift). Contacts of the race secretary ([secretary@sfu.org.ua](mailto:secretary@sfu.org.ua) +380503342701 – Viber, WhatsUp). TCM will be held in the Race Office or online.

Registration is held in the race office before first TCM.

#### **5. SKI PASSES**

Team captains can pick up the skipasses at the Cashier Desk (bottom station of the ski lift) according to the entry form.

#### **6. ENTRY FEES**

Entry fees are 50 EUR (per person per competition day). Entry fees are to be paid at the Race Office (cash) before 1<sup>st</sup> competition day.

#### **7. BIBS**

All competitors must wear bibs during all official training, competition and award ceremonies.

#### **8. LIABILITY \ ACCIDENT INSURANCE**

All athletes, officials and other members of the National Ski Associations who will attend and participate in the competitions shall do so at their own risk of any injuries or losses suffered or incurred during the competitions.

Every competitor must have his/her own medical insurance. In the case of accidents on courses during competition or training, the medical personnel from the Organizing Committee will be responsible for any medical decision to local hospital in co-operation with the respective team's medical personnel.

#### **9. PROGRAM** (changes may be possible)

February 1 <sup>st</sup>	Arrival of Teams, registration, shaping.
February 2 <sup>nd</sup>	Shaping & Training. TCM after training
February 3 <sup>rd</sup>	Official Training.
February 4 <sup>th</sup>	Competition. Qualification \ Finals.
February 5 <sup>th</sup>	Competition. Award ceremony (scene in the cross section of ski lifts)
February 6 <sup>th</sup>	Departure. <i>*Detailed program will be determined at the 1<sup>st</sup> TCM.</i>

## ***10. COVID-19 Regulations***

As the situation changes constantly we will give the updated information (in case of changes) one week before official arrival. Generally, the information for entry is provided at the governmental resource <https://visitukraine.today/>. By November 15<sup>th</sup> the entry is allowed to all foreign citizens, holders of a temporary residence permit, as well as stateless persons need to have one of the following documents:

- a document confirming the receipt of a full course of vaccination with vaccines that are included by WHO in the list of approved for use in emergency situations; or
- foreign COVID certificate confirming vaccination against COVID-19 with 1, 2 or more doses vaccines that are included in the WHO list of approved for emergency use, negative test result for COVID-19 by PCR or recovery of a person from COVID-19; or
- a negative PCR test result or rapid test for the SARS-CoV-2 antigen (RAT, Ag) that was done no more than 72 hours before entry.

Tests for entry into Ukraine are not required for vaccinated persons and children under 12.

Foreign tourists over 18 years old who have not been vaccinated against coronavirus and cross the state border to enter must install the Vdoma mobile app, which monitors self-isolation, regardless of the length of stay on the territory of Ukraine.

Self-isolation is not required if you undergo PCR testing or a rapid antigen test within 72 hours of entry and get a negative result.

All travelers must possess the medical insurance, covering expenses in case of Covid.

There will be possibility to conduct PCR test at the competition site (50 Eur). If You will need any such, please, let us know the requested dates.
