Competitions shall be carried out in accordance with recommendations from Polish health authorities (National Institute of Hygiene and Sanitary, Epidemiological Station), World Health Organisation and International Ski Federation.

Exception

As of 18th February 2022 there are **no restrictions** on entering the country (incl. quarantine) for teams and officials travelling into Poland for international sport events provided that entering individuals are able to prove the fact of the event being held and that they are officially entered as participating athletes/team officials, judges, accredited journalists.

After name entries are submitted by given deadlines, LOC will provide each team/official with written confirmation that might be required on entering Poland.

Shall there be any updates, we will inform everybody concerned accordingly.

All entered event participants being holders of FIS passport shall regularly follow general FIS Passport regulations, i.e. provide/fill in as required pre-entry health questionnaire and daily questionnaire, incl. test result.

Deadline for FIS passport application for the event – 25th February 2022.

All accredited FIS passport holders are required to provide negative RT PCR result not older than 48 hours on arrival. The result shall be entered into the FIS passport application not later than 12 hours before arrival day.

ENTERING POLAND

On entering the country

- Passenger Locator Form to be filled up when travelling on public transport (plane, train, ship, etc.)
- to be filled online here <https://aplikacje.gov.pl/app/klp/#/home>
- or available in .pdf

also available on board a plane

- General (see exception above)

travelling from EU, Schengen and Turkey

- o proof of vaccination – Covid passport (EU approved – Pfizer, Moderna, Astra Zeneca 14 days after 2nd dose; Johnson – 14 days after 1st dose)
- o or, PCR or antigen test not older than 48 hours
- o or, recovered from Covid-19 within the last 180 days – only official entry in the Covid passport accepted

travelling from outside EU, Schengen or Turkey

- PCR or antigen test not older than 24 hours (even if vaccinated)

Use your own transportation whenever possible, both travelling into Poland and once on site.

For interested teams LOC shall facilitate car rental from airports.

On request, airport pick-ups will be provided, as well as on-site shuttle made available. Drivers will wear face protection at all times. Vehicles shall be sanitised regularly.

Please be aware of various restrictions in countries on your way to Poland.

In case of doubt (symptoms, contact, ambiguous C-19 testing results) person in question will be subject to antigen test on site before accreditation is issued.

Decision will be made by Event C-19 Coordinator MD Stanisław Szymanik (24/7 coordination with local COVID Centre), who will coordinate the process in person. The test will be provided at the person in question's cost.

In case a test is ordered, the person in question will be required to sign a relevant consent for the LOC to collect his/her test result from relevant laboratory/hospital.

- RT_PCR test price – 100 Euro pp.
- Antigen test price – 40 Euro pp.

POLAND'S GENERAL SITUATION

face masks are required and mandatory in **all public indoor areas** (shops, public transportation, offices, etc.), as well as all **hotel public areas** (corridors, lifts, restaurant until seated)

hand sanitation

social distancing 1,5-2 metres

OTHER INFORMATION

shops and shopping malls generally open

restaurants, bars, etc. generally open

limit of people inside stores/shops/restaurants/ bars based on the available space public

some actions might not comply with relevant national laws and/or COVID-19 restrictions and as such can subject to monetary fines or criminal prosecution

NSA/LOC key officials / VOLUNTEERS

all NSA/LOC staff working in contact with teams will have been pre-tested on site

adjusted number of staff/volunteers according to requirements

ACCREDITATION

accreditations should be picked up by team's/group's representative

HOTELS offered by LOC

access to hotel with valid accreditation only

room service on request only

face masks in all hotel public areas (corridors, lifts, restaurant until seated)

hand sanitation

social distancing 1,5-2 metres

isolation rooms available in the hotel

recommended use of staircases rather than lifts

VENUES GENERAL

- # changing rooms and service containers – sanitised daily
- # limited access to athletes' compound
- # catering – no sitting places for teams/athletes available
- # face masks required, excluding warm-up
- # lift access at the jumping hill – 1 person at a time, with face masks only
- # hand sanitation liquids available at various places at the venues
- # if re-used, starting bibs will be sanitised before re-use
- # prize-giving ceremony held according to FIS C-19 guidelines
- # press conference – TBC, if organised online only

WARM-UP ROOM AT START (JUMPING HILL)

- # please limit the number of athletes in the warm-up room at start
- # only bottled drinks, no open snacks

EQUIPMENT CONTROL AT START (JUMPING HILL)

- # Control box sanitised before/between each round
- # Equipment controller and LOC helpers with face masks on

COACHES' PLATFORM (JUMPING HILL)

- # face masks required
- # social distancing
- # please limit the number of coaches on coaches' stand

EXIT GATE (JUMPING HILL) / START & FINISH AREA CC

- # social distancing
- # please limit the number of team officials in the cool-down area
- # put your face mask on

EQUIPMENT CONTROL AT EXIT GATE (JUMPING HILL)

- # equipment controller + assistant + given athlete allowed into the equipment control room at exit gate
- # face masks required
- # LOC helpers at social distance from athletes

MIXED ZONE

- # TV/Radio/Press at social distance
- # face masks required
- # double fencing between athletes and media

TCM

- # TCM presentation, start lists available electronically
- # only 1 team representative per TCM on site
- # social distancing
- # **FFP 2 face masks required indoor**

FFP2 face masks required for all team members, officials and any LOC staff in contact with teams (specially indoor)!!!

face mask required in all competition venues and red bubble areas!!!
