COVID-19 Health, Safety and Testing Protocol

Teams, FIS, Media, Judges



To be allowed for the Official training you need:

1. FOR ENTERING the RUSSIAN FEDERATION you have to provide the printed version of negative PCR test result in English carried out non later that 72 hrs before the border crossing;

2. Upon arrival at the resort for admission to official training before the competition, you must pass a PCR test for COVID-19 on 08th of December (testing is carried out at the expense of the team, the cost of PCR testing is 70 Eur, the payment is accepted only by non-contact method by VISA/Mastercard);

The test results will come electronically to the team captain e-mail address. Attention! The participants will not be allowed for the official training without the testing.

3. Fill out the FIS questionnaire. To process your FIS passport: <https://fispassport.fis-ski.com/fis/>

If necessary, for further movement of participants after the end of the Competition, the opportunity to re-test at their own expense will be provided the 11 of December (estimated cost 70 Euros) The test results will be available on the morning the 12 of december



The previously infected person is allowed to join the competition after the 14 days quarantine completed and with the negative PCR test provided

The participants are required to upload the PCR test results using the FIS passport app: <https://fispassport.fis-ski.com/fis/>

Health protocol and hygiene



1. Wearing the mouth and nose protector (face mask) is obligatory on the entire event side, in the rest rooms, using all type of transfers, cars, buses, gondolas, chair lifts, in the common areas of the hotel with the exception for the mealtimes and for the training/competition.

2. Always follow the rules of the social distancing (2 meters), do not use the public transport and try to avoid the shopping centers visiting.

3. Regular hand washing or hand sanitizing is necessary.

4. All the participants, judges, organizers and other persons at the entrance to the Venue as well as accommodation area, will undergo the thermometry procedure by noncontact means.



Observe these rules when moving to the competition venue, being in public places, during the competition and during your free time.




Participants ' accommodation and safety recommendations

Provide accommodation for participants of Competitions, athletes, coaches, sports referees, other service personnel-no more than 2 people in the room; managers (representatives) of teams-no more than 1 person in the room (if possible).

When placing participants of the FIS Snowboard World Cup in the sanatorium, the following security measures will be provided:

- non-contact thermometry;
- accommodation of participants of Competitions in county houses;
- provision of meals for participants in the designated halls of the sanatorium without access by unauthorized persons.



The captain or representative of the team can register for the entire team while the others wait in front of the sanatorium or in transport.

All participants need to:

- to limit the routes of movement, to leave the place of temporary residence only when there is a special need for domestic and training needs;
- exclude contacts with persons without personal contact with whom you can do without during a sports event;
- exclude physical contact (handshakes, hugs);
- avoid personal contact with non-members of your team; eliminate the use of paper media transferred from hand to hand;
- use electronic versions of documents (pdf, photo), which can be distributed using messengers or e-mail;
- all participants should carefully indicate the test results and location in the COVID-19 passport.

Action protocol in case of COVID related symptoms



Part 1

All the participants, judges, Media, FIS representatives and other officials will undergo the thermometry procedure by non contacts means.

If the participants of the competition have the following symptoms (runny nose, cough, fever: above 37°C):

1. Inform the organizing Committee immediately;
2. Isolate in a room/specially designated room (insulator house No. 11), excluding any personal contact with anyone;
3. Organize medical supervision and laboratory examination for COVID-19 coronavirus infection at your own expense.



If there is a positive result of the PCR test in the participant of the Competition, it is necessary to:

- identify persons who have been in contact with the patient within the last 72 hours;
- the specified persons who were in contact with the carrier of a positive test must pass a laboratory examination for COVID-19 coronavirus infection at their own expense (PCR test) and pass quarantine until the negative result will be obtained



Action protocol in case of COVID related symptoms

Part 2

The decision to isolate or stay in a medical institution of a participant with a positive PCR test is made by the person responsible for medical support of the competition.

Financial expenses in case of isolation and treatment of a participant with signs of a new coronavirus infection COVID-19 and persons who came into contact with them during the competition, before returning to their place of permanent residence, are borne by the participants. The Russian Snowboard Federation provides assistance in sending the participant.

CONDUCTING COMPETITIONS

The meeting of team leaders with the draw of participants is held in person (in the same format) in compliance with the following rules

- no more than one representative (manager/coach) from one sports team at the meeting;
- the seating arrangement of the participants of the meeting should be staggered in accordance with the social distance of at least 1.5 meters;
- all participants of the meeting are required to use personal protective equipment (masks, gloves) and observe a social distance of at least 1.5 meters;
- at the entrance to the meeting room, it is necessary to arrange a place for treating hands with a skin antiseptic, as well as airing the room.
- the Chief Secretary, after the draw, must prepare the badge numbers, disinfected and arranged in separate packages, for the head/coach of each team to be issued remotely.

When using the cable car, the following rules must be observed:

- in case of a queue, a social distance of at least 1.5 meters must be observed;
- joint lifting of athletes, coaches, and staff of different teams is not recommended;
- participants of the Competition use specially allocated cabins for them

At the end of the competition, the athlete must put the starting number in a special plastic bag (container) and maintain a social distance with other athletes.

If there is evidence of an acute infection you will be provided with a mask, the medical personnel are equipped and isolation will be required. The local public health authority will be notified, and their protocols will be followed. An accreditation will not be issued until you have been cleared by the local public health authority.

Athletes and accredited persons should be reassured that declaring travel from high risk area will not preclude participation, but that they should expect to be more closely monitored.

The personal information provided is treated strictly confidentially by the Local Organising Committee and FIS. It will only be used for the purpose of assessing whether the applicant can be granted or maintain accreditation in view of the COVID-19 outbreak. Local and global public health requirements will determine the length of time the data is retained.
