### Registration \ Race Office

Registration will be held in the Race office located on the building State Institution State Olympic Center for Winter Sports. (Slope №2)

TCM will be held in Race Office according to the program schedule. Closest parking to the race office is Bukovel Central Reception.

**Entry fees.** Entry fees – 50 EUR (includes ski passes) per competitor per competition day to be paid in cash to the Race Secretary before first TCM.

**Transportation.** Closest airports are: Lviv (LWO) with approximately 5 hours travel and Ivano-Frankivsk airport (IFO) with 2 hours. The cost of one-way trip from Lviv makes approximately 3800 UAH (130 EUR per minivan – up to 8 persons).

**Helmets.** Please, note, that according to the Bukovel Ski Resort safety policy, all those on skis **MUST** wear helmets (otherwise they won't be allowed to go to the chairlift for skiers). Going up without skis (or on the chairlift for pedestrians) helmet is not obligatory.

**Liability \ accident insurance.**

All athletes, officials and other members of the National Ski Associations who will attend and participate in the competitions shall do so at their own risk of any injuries or losses suffered or incurred during the competitions. Every competitor must have his/her own medical insurance also covering the covid-19.

### **Covid-19 procedures and restrictions:**

As the situation changes constantly we will give the updated information (in case of changes) one week before official arrival. Generally, the information for entry is provided at the governmental resource <https://visitukraine.today/>. By November 15th the entry is allowed to all foreign citizens, holders of a temporary residence permit, as well as stateless persons need to have one of the following documents:

- a document confirming the receipt of a full course of vaccination with vaccines that are included by WHO in the list of approved for use in emergency situations; or
- foreign COVID certificate confirming vaccination against COVID-19 with 1, 2 or more doses vaccines that are included in the WHO list of approved for emergency use, negative test result for COVID-19 by PCR or recovery of a person from COVID-19; or
- a negative PCR test result or rapid test for the SARS-CoV-2 antigen (RAT, Ag) that was done no more than 72 hours before entry.

Tests for entry into Ukraine are not required for vaccinated persons and children under 12.

Foreign tourists over 18 years old who have not been vaccinated against coronavirus and cross the state border to enter must install the Vdoma mobile app, which monitors self-isolation, regardless of the length of stay on the territory of Ukraine.

Self-isolation is not required if you undergo PCR testing or a rapid antigen test within 72 hours of entry and get a negative result.

All travelers must possess the medical insurance, covering expenses in case of Covid. Upon request there is a possibility to make a PCR test with transfer to Ivano-Frankivsk.
