WE MUST COORDINATE THIS TRAVEL FROM GREEN BAY AS YOU WILL BE TRANSPORTED 160 KM TO IRON MOUNTAIN. Please contact me at your earliest convenience if you intend on sending a team so we can make appropriate arrangements for their stay, names are not necessary at this point. Please also let me know if you will be arranging your own ground transportation or are needing our assistance. If arranging your own ground transportation, I will still need to know your arrival and departure dates in Iron Mountain to arrange lodging. As you know, we MUST secure 8 teams to have a competition and your participation would be welcomed and appreciated. Deadline for entry February 2, 2024.
