Points and Ranking

- Athletes will receive USASA Regional and National Ranking points in your age group and FIS points. The competitions will be scored on an open range and then age group points will be assigned for the USASA result. The FIS result will not reflect age groups. All results will also be scored on the WSPL.

FIS rules will be followed and USASA rules respected. Final formats will be determined at the TC meeting prior to the competition. All athletes must be represented at the TC meeting. Coaches are required to have a membership with both USASA and US Ski and Snowboard

The waiver needs to be completed on-line / this will be posted the week prior to the event. No Waiver / No Ticket / No exception. We will post the link on the Big Mountain West Team App. Link to Team App is here: **The PC Mtn Resort waiver is an event waiver and is required regardless if you are an Epic passholder.**
