The Organizing Committee will host the event in accordance with the competition rules of the International Ski Federation and Snowboard (FIS) and the World Cup Rules 2024/2025. All national Ski Associations affiliated with FIS are invited to compete.

In order to help you plan your stay we have enclosed some information regarding the event and contact information in case of questions.

Idre Fjäll and the Organizing Committee are looking forward to hosting you at Idre Fjäll during the FIS Ski Cross World Cup Final.

Entries

Entries will be accepted from National Ski Associations following FIS quotas and rules. The online registration system is accessed on the FIS Homepage <http://www.fis-ski.com> in the Member Section.

All quotas and entries are according to the FIS World Cup Rules 2024/2025. Only those competitors who are entered by National Associations are eligible and the number of participants is limited under current World Cup quotas.

Provisional Entries: Sunday February 16th, 2025

Each National Association must inform the Organizers about the expected total number of team members (Names, FIS Codes and Gender, team officials) arrival and departure dates and rooming needs (competitors, coaches, accompanying persons and service personnel). This needs to be done using the "Competition Online Entry System" and respecting the deadlines fixed and announced by the OC (40 days before the first competition day).

Confirmation of Final Entries: Tuesday, March 18th, 2025

No later than 10 days before the competition day the NSA must inform the OC of its final entries (Names, FIS Code and Gender) with their arrival and departure dates. The NSA must also inform the OC about the arrival and departure dates of the team officials. Please note! For any changes after the final deadline, the Organizing Committee may invoice the costs incurred for cancelled accommodation to the National Ski Association concerned. Teams or persons who register after the deadline will not be eligible for FIS rates.

The World Cup final, 30th of March, will be executed as a limited field race 32 men / 16 woman, according the current World Cup Standing list. If qualified athletes are not on site, the field will be fulfilled with the next ranked athlete, which is on site.

Accommodation and meals

Teams will pay the fee for accommodation including half-board according to the FIS World Cup Rules 2024/2025 from Tuesday March 25th until Monday March 31st.

Athletes, Coaches and Team Officials will be hosted in apartments at Idre Fjäll. The OC will charge 80 CHF including tourist tax each day. The Top 5 men and women in the World Cup Standings we will waive the FIS rate as per the current world cup standing. All teams shall be provided with 2 single rooms at the FIS rate CHF 80. Allocation of additional single rooms per team must be provided at a rate of 120 CHF including tourist tax, credit cards and bank fees according to the following table:

3 or 4 officials = 1 additional single room

5 or 6 officials = 2 additional single rooms

7 or more officials = 3 additional single rooms

If more single rooms are requested, this will be subject to availability and local market rates will apply.



The exchange rate of transactions in connection to FIS Ski Cross World Cup Final Idre Fjäll 2024 will be fixed based on the exchange rate of December 17th, 2024: 1 CHF equals 12.9477 <https://www.forex.se/valuta/chf>

The half-board package at Idre Fjäll includes breakfast and dinner. We can as well offer lunch for 165 Swedish kronor in the restaurant where breakfast and dinner is served. Please contact Amelia at amelia.westblad@idrefjall.se if you wish or do not wish to book lunch.

Each team will pay all of their accommodation expenses upon arrival (major credit cards only). Each team will be held responsible for any damage incurred during their stay. Extra expenses such as phone, pay-tv or bar bills are to be paid by the teams or athletes. Please enter the team accommodation requirements in the Competition Online Entry System including a provisional list regarding rooms sharing by February 16th, 2025.

Ski Waxing Rooms

Ski waxing and storage facilities will be located approximately 350 meters from the race arena (100 meters from the lift). Teams will be informed on location of waxing cabins upon arrival.

Extra training and Glide testing

Idre Fjäll offers all teams extra training from the 25th of March. Idre Fjäll will offer Glide testing from Tuesday March 25th. If you are interested in one or both we kindly ask you to contact Amelia Westblad for more information.

Travel to Idre Fjäll

Idre Fjäll is situated in the northwest of the county of Dalarna in Sweden, close to the Norwegian border <https://goo.gl/maps/iAXLkYB6PwK2>. Stockholm Arlanda Airport is about five hours by car from Idre Fjäll. You can also travel by train from Stockholm Arlanda Airport to Mora. From Gardermoen Oslo Airport it is around a four-hour drive to Idre Fjäll. Sälen does have a domestic airport and from Sälen it is approximately 1,5 hours with car to Idre Fjäll.

Airport Transfer:

Teams are responsible for their own transportation, but the organizing committee provides assistance in arrangement of bus transfer from Arlanda Airport and Gardemoen Airport to Idre Fjäll upon request. Accreditation

Accreditation is received at the Race Office. Race Office will open 14:00, Tuesday, March 25th. Please accredit only persons that are really working during the world cup. The accreditation will work as Skipass as well.

Regulations

The Organizing Committee will follow all qualifications as outlined in current rules and formula for the FIS Freestyle Ski World Cup Rules 2024/2025 and any precision and/or amendments to these rules.

Bibs

The competitors must wear bibs during training, the race and award ceremonies. The bib also work as skipass.

Prize Money and Prize Money Taxes

Prize money will be transferred to the athletes' account. A withholding tax will be retained as per Swedish Income Tax Law. See Prize money breakdown below:

Please note: NSAs must manage all information required for prize money using the FIS Athlete Registration module in the FIS member section. All bank information **MUST** be uploaded to the FIS database prior to the Finals. The organizing Committee might need to ask about a copy of the athlete's passport due to Swedish laws, the athletes will be contacted by the address they have listed in the FIS Prize money system.

Insurance and liability

Each competitor must have his/her own medical insurance. The Organizing Committee sponsors, suppliers, their agents, the FIS and the Swedish National Ski Association do not take any responsibility for accidents, damaged or lost equipment during the event. All athletes, officials and members of the National Associations who attend and participate in the event, shall do so at their own risk. The OC, sponsors and suppliers, their agents, employees and volunteers shall not be held responsible for any losses or injuries incurred or suffered by any athlete, team official or other person in conjunction with the Organizing or staging of the event.

Anti-Doping

Anti-Doping testing may be conducted in accordance with the rules and regulations set forth by FIS.
