REGISTRATION – ENTRIES

Entries must be in accordance with the FIS quotas and rules.

These can be found on the FIS website under SNOWBOARD / SNOWBOARD CROSS / DOCUMENTS / WORLD CUP RULES SNOWBOARD FREESTYLE FREESKI 25/26.

All entries must be made through the FIS Online Registration System, through the FIS home page within the mentioned deadlines: <https://profile.fis-ski.com/login>.

FIS has established Nation Quotas for World Cups. National Snowboard Teams can only enter World Cup Competitors according to the Quota limitations.

Provisional Entries: 2th November 2025.

Each National Association must inform the Organizers about the expected number of team members (Names, FIS Codes and Gender, team officials), arrival and departure dates, and rooming needs (competitors, coaches, accompanying persons, and service personnel). This needs to be done using the «Competition Online Entry System».

Confirmation of Final Entries: 2nd December 2025.

The NSA must inform the OC of its final entries (Names, FIS Code, and Gender) with their arrival and departure dates. In addition, the NSA must also notify the OC about the arrival and departure dates of the team officials.

Bear in mind that for any changes made after the final deadline, the Organizing Committee may charge the NSA concerned for any costs incurred. Teams or people who register after the deadline will not be eligible for FIS rates.

PARTICIPATION - FEE

According to the FIS Snowboard World Cup Rules a total mandatory Participation Fee of **CHF 90** per each competitor, has to be paid to the organizing committee.

The fee includes: one official training, one qualification and one competition day.

The Participation Fee has to be paid per team at the Race Office in cash or by credit card.

ACCOMMODATION AND WAX-ROOM

Teams will be hosted for lodging and dinner at different partner hotels due to the FIS Snowboard World Cup rules (5/6 nights at the FIS rate, **CHF 100**) from December 9th to December 15th.

Earlier or later overnights do not benefit the FIS rate.

Official Arriving Day: 9th December.

Official Departure Day: 15th December.

PRIZE MONEY

Prize money will be Euro 34,921 per gender for each event.

The amount for each winner includes withholding tax.

All prize money will be issued following the new FIS prize money process. NSAs must manage all information required for prize money using the FIS Athlete Registration mod-ule in the FIS member section. All bank information MUST be uploaded to the FIS data-base prior to Finals. Athletes without the correct bank information uploaded to the FIS system will experience a delay in prize money bank transfer.

In order to process the prize money, all winners must provide valid bank details, identification, and complete appropriate tax documentation.

Prize money will be awarded to the top 10 men and top 10 women.

MEDICAL AND ANTI-DOPING

Anti-Doping control testing may be conducted in accordance with the rules and regulations set forth by FIS.

RULES

The Organizing Committee reserves the right to modify the schedule of the event stated in the program, depending on snow conditions and/or decisions of the competition jury.

BIBS

The competitors must wear bibs during trainings, competition and award ceremonies. Please note that there will be a deposit of € 20 for each bib, payable in cash at the race office.

TRANSPORTATION

Teams are responsible for their own transportation.

LIABILITY

All athletes, officials, and other representatives of National Associations will attend at their own risk. The organizer declines any liability for damages or injuries of athletes, officials, or other people, as well as second and third-party claims during the event. Every competitor must have their medical insurance.
